Petitioner's Response Respondent Motion To Dismiss

Now Comes HERMAN FLORES, the Petitioner, pro se, hereinafter respectfully move this honorable Court to denied respondents motion to dismissed and grant the petitioner relief. Petitioner support the facts as follows:

Background

The Petitioner herein incorporates as background in the respondent motion to dismiss as his entire background

Argument

The respondent argues that the petitioner petition should be dismiss for two reason. First, "the Petitioner's *Zadvydas* claim is premature on its face because he has not been detained post-final order of removal for six months."

Second, "even assuming Petitioner could state a claim for relief under Zadvydas - which he cannot- he fails to show that he is entitled to relief."

Petitioner's Petition Should Not Be Dismissed As Premature Under Zadvydas

As per the Respondent first reason – Petitioner entered ICE /ERO custody in August 2, 2024. and was ordered removed on September 9, 2024. therefore Petitioner post-final order of removal date commenced on September 9, 2024. Petitioner filed his writ of habeas corpus claim on February 24, 2025 five months and fifteen days after he was ordered removed and thirteen days short of six months pursuant to *Zadvydas*. The Petitioner's six-month presumptively reasonable detention period under Zadvydas ended on or about March 9, 2025 before the Respondent filed his response to the Petitioner' Writ of Habeas Corpus pursuant to 28 U.S.C. Section 2241and after Petitioner filed his response to the Respondent's response. Therefore, the Respondent did not suffer any prejudice. In other words the Respondent was allowed the fair opportunity of six months to address and respond to the Petitioner's Motion.

Petitioner Is Entitled To Relief Under Zadvydas

Petitioner has been detained for an unreasonably prolonged period after his order of removal became final, and, for this reason, should be "discharged from his unconstitutional immigration confinement."

Accordingly, the Supreme Court recognized that a six-month detention was "presumptively reasonable" under the statute. Id. at 689. For the detention to remain reasonable, "as the period of prior

post-removal confinement grows, what counts as the 'reasonably foreseeable future' conversely would have to shrink." Id. This presumption applies uniformly to all categories of aliens covered by section 1231. See Tran v. Mukasey. 515 F.3d 478, 482 (5th Cir. 2008) (citing Clark v. Martinez, 543 U.S. 371, 378, 125 S. Ct. 716, 160 L. Ed. 2D 734 (2005)). However, the Supreme Court noted that this presumption does not mean that every alien must be released after six months. See Zadvydas, 533 U.S. at 689.

After the presumptively reasonable six-month period expires, aliens can attack the reasonableness of their detention by providing "good reason to believe that there is no significant likelihood of removal in the reasonably foreseeable future." Id.; *Andrade v. Gonzales. 459 F.3d 538*, 543 (5th Cir. 2006). As such, aliens bear the initial burden of proof. See *Andrade*, 459 F.3d at 543-44. To meet this burden, aliens must allege sufficient evidence establishing "that there is no significant likelihood of removal in the reasonably foreseeable future," and not merely offer conclusory statements suggesting that removal will not occur immediately following the resolution of their appeals. Id. (citing *Zadvydas*, 553 U.S. at 701). Once the alien makes that showing, "the Government must respond with evidence sufficient to rebut [it]." *Zadvydas*, 553 U.S. at 701.

Here, Petitioner has been in Respondents' custody beyond the presumptively reasonable sixmonth period of detention. Petitioner's prolonged detention of over six months in ICE custody violates his constitutional rights because his removal is not reasonably foreseeable. Accordingly, Petitioner seeks release from custody, or, at the very least, an individualized hearing to determine his custody status. 28 Pet. at 13; Resp. 6, 11.

Since August of 2024 Petitioner has been diligently putting fort the effort to assist ICE/ERO in

obtaining is travel document and have been adamant as to why ICE/ERO have not yet receive his travel document. Petitioner emailed his ICE Officer(s) on numerous occasions in quest of obtaining his travel document.

Petitioner emailed his ICE Officer Addison on August 7, 2024 Time: 18: 59: (Summary of Request) "I need your help". "So. Hi, I need your help me with my deportation process as you know I want to go back home soon – anything you can do for me or you need from me please. Let me know. Appreciate." If you do not have it, we will have to fill out an application and apply for you to enter into your country."

On March 01, 2025, Time 09:26 (Conformation# ICE/ERO Mr. sddo Jackson emailed Petitioner: "Your travel docs have been put on hold and we are waiting for confirmation once that is complete the process of getting you removed will being you have been told this numerous times."

to go back to Nicaragua I have my wife and kinds waiting please".

On March 23, 2025, Time 14:15 (Conformation #) Mr. Carter emailed Petitioner: "Good afternoon we've spoken about this concern your TD – is still pending when the TD is issued we will be able to move forward with your removal until the - we have to wait I've done what needed on our part and agin – when the TD is issued we can move forward with removal."

It is evident by the record that Petitioner did everything beyond and withing his ability to aid and ICE/ERO with more than sufficient information to obtain his travel document. The Petitioner cooperated in every way that he could, he gave his all and his last to ICE/ERO since August 8, 2024, two day after he was detained in immigration custody on August 6, 2024. The Petitioner did everything asked of ICE/ERO - almost for nine Petitioner has been constantly voluntarily assisting ICE/ERO in a number of ways to obtain his travel document so he could be deported to his country and still to date ICE/ERO has failed to make any progress in obtaining the Petitioner's travel document. Here, the Petitioner make the showing of sufficient evidence establishing "that there is no significant likelihood of removal in the reasonably foreseeable future and the Government failed to meet its burden of showing sufficient evidence. See Zadvydas, 553 U.S. at 701.

Conclusion

For the aforementioned reasons, this Court should find that Respondent is bound by the Due Process Clause to Grant Petitioner's Petition for release from custody.
