Supplemental Brief

NOW, Inmate Karel Omar Aguilar Estrada, serving a term of incarceration within this Court's jurisdiction, provides a supplement brief regarding the above-captioned case.

Petitioner asserts the claim that the Respondent has substantively affected Aguilar-Estrada's incarceration at the LOW FCI Allenwood facility. The Respondent submitted documentation claiming a final order of removal was issued on or about February 25, 2025. By doing so, Aguilar-Estrada is now being denied the benefit of applied FSA Time Credits (FTC) toward his early release. Petitioner claims a final order of removal cannot be issued while an alien is in appeals and the Respondent should remand any documentation which has claimed a final order of removal regarding the subject alien under A  Aguilar-Estrada has filed appeals within Respondent's agency without reply.

The Allenwood FCI LOW facility conducted a review of Aguilar-Estrada's incarceration which documents an inmate cannot apply FTCs towards early release while under a final order of removal. Petitioner restates the claim that the actions of the Respondent have substantively affected Aguilar-Estrada's incarceration namely disallowing the BOP from applying his earned FTCs by claiming a final order of removal has been issued.
