**STATUS REPORT REGARDING COMPLIANCE WITH THE COURT'S MAY 5, 2025,
ORDER**

Respondents file this status report regarding their compliance with the Court's May 5, 2025, Order, requiring a bond hearing for Petitioner by May 12, 2025. See ECF No. 14.

Petitioner received a bond hearing and was granted bond; however, the bond hearing did not occur until May 13, 2025. On May 5, 2025, the Court entered its Order requiring a bond hearing for Petitioner by May 12, 2025. See ECF No. 14. According to immigration court administrators, the immigration court was having problems with the electronic records for this particular case. Given those problems, a bond hearing could

not be scheduled for Petitioner until May 12, 2025. On May 12, 2025, though, the immigration judge could not access portions of the electronic record for this case, particularly evidence submitted by Petitioner. As a result, the immigration judge rescheduled Petitioner's bond hearing for the next day, May 13, 2025. The bond hearing was then held on May 13, and the immigration judge granted Petitioner bond the following day, May 14, 2025. In sum, Petitioner received a bond hearing per the Court's Order and was granted bond, but the bond hearing was held on May 13, 2025, due to problems with the immigration court's electronic records.
