Request for Immediate release or Immediate deportation

When I got arrested by Ice Officers of Atlanta , they told me firstly that I would stay a couple of days in Custody before getting deported . They did not deport me on this day because there was a lot of snow upon the Airport tracks . However , they didn't give me any notice to sign regarding the deportation , they just asked me if I wished to see the Judge or not and I said " yes " . I never refused to get deported nor refused to sign the paperwork for deportation . After approximately 44 Days in custody I changed my mind and I decided to file an Asylum application to fight my case in addition to my withholding of removal proceedings . I didn't know that Asylum proceedings would take so much time and you played with my misunderstanding of some of the Immigration laws to persecute me further by keeping me as much time you please inside that Detention . You had the obligation to tell me that Asylum proceedings would take so much time and I am not sure that within a Democracy , seeking asylum does allow you to prevent somebody from his freedom as much time...I want you to take a look at the section in INA 241(a) and 237(a) as I never attempted to jeopardize the deportation proceedings . I cooperated with Ice Officers and if I filed an asylum application it is because in my country , there are some evil politicians and cruel persons like you (from police) who want to persecute me ! If you think that being an Alien seeking Asylum in United States , allows you to keep me locked up against my will for many months , you are wrong ! You were supposed to deport me within 3 months and I have never been deported within that time and if you were willing to keep me locked up further , you were supposed to prove that I would pose some problems to the community . I never got in troubles with the Police when I was neither in Miami nor in Atlanta and Ice Officers in Atlanta don't have never mailed to me any warning notice regarding my immigration problems .

I didn't get my Student Visa as I wished to because I was Indigent and my french counsel of Miami perfectly knew about it ! I want this persecution to stop right now as I have spent more than 130 days in Custody and I am asking you as I did on February and on March 2025 for DEPORTATION if you are unwilling to release me from custody !!!!!!!!! I sent a lot of message to my Ice Officer with the tablet including those on May 15th 2025 to remind him to deport me and to revoke my asylum proceedings , if he ~~was~~ unwilling to release me very soon ! All the conversation is recorded as you cannot tell the court that I attempted to jeopardize the removal proceedings . You let me only 2 choices : Either fighting my own case in custody for several years or getting deported . Americans leaders want to give

some lessons to the world within the TV news saying as example that the Hamas is a terrorist Organization and that they persecute the Jews and it's truth ! But why do they criticize Hamas and give lessons to others people if they act exactly like them over Alien People by detaining them as hostages for several months (or several years) inside their facilities ? So right now I have been persecuted enough for no reason , preventing from my freedom for more than 130 days and I want it to stop !!!! You don't have any right over me , you just have the right to leave me alone and to let me Free if I don't have any charges over my criminal record . You are liars , you act like terrorists , you don't have any cleverness , you are evil and wicked and you don't have any consideration for human life (except for American people) . I asked you many time to let me go to Canada if you were unwilling to release me , why are you keep going on with that illegal detention ??? what do you want from me ???? I don't have any money , leave me alone , stop that persecution !!!!!!!

You did not respect ^{the}any rules and you were supposed to deport me within 90 days !!!!!!! If you don't want to release me from custody , just let me go to my country , what is the problem ? what does it change to you that I be free or in custody ? I never attempted to the safety of anybody and I have a problem with depression which cannot be fixed inside that facility where my human rights are not guaranteed . I struggle to fall asleep each night since a couple of weeks ago . I cannot sleep well anymore as my anxiety increased so much within these last passed weeks . I know that you don't care about it and you just care about yourselves but I want to recover my freedom right now and I don't have to wait anymore for it and I want to cure myself about the depression .

I learned enough about Immigration laws to know that you don't respect my human rights at all ! Please let me go to Canada : this country is a real democracy and the Canadian Leaders are human . It is not the same system and if I knew that I would spend so much time in Custody for no reason , I would ^{have been}go to Canada You wasted 130 days from my life for no reason and you voluntary lied many times to me and to your own hierarchy within your paperwork . Just let me get out ! I cannot deal with that situation anymore . Do you think that you are acting fairly with me ? Can you give an answer to the Court and explain them why are you keeping me as much time in Detention ? under which law ? Why did you revoke my Visa Waiver program on October 16th 2024 ? I am allowed to work in United States , I am allowed to work in United States , I am allowed to work in United States !!!!!!! Why don't you are willing to let me recover my Freedom ? can you just give me an answer ? I am waiting for your answer since January 2025 , thanks.
