Dear Judge,

I awaited since May 2<sup>nd</sup> 2025 for the answer from the respondent and it is not a huge surprise that he didn't address neither to the Court nor to me that notice yet. Tomorrow will be the last chance as he got 21 days to submit what he was ordered for . It is exactly what I expected , which means I already knew that the respondent would not answer on time as he doesn't have a lot of acceptable arguments to keep me as much time inside the facility . The only argument that he may use is the one saying I am an Alien without any legal Immigration status but I claimed and reported many times the reasons I got an Illegal Immigration status ( due the threats and the Illegal cancellation of my Visa from the Ice Officers in Fort Lauderdale on October 16<sup>th</sup> 2024) . The second explanation for which I am currently Illegal is because I was Indigent when I started my Visa Student request by my USCIS account online and I didn't have the necessary funds to pay that Visa . As I remember , being Indigent in United States is not a crime...

Since that Time I provided all the evidences and Medical reports stating that I am not a danger for US Community . I pledged also that I won't try to flee DHS and that I was cooperating with US authorities for my Removal proceedings and to fix my Immigration problem . Homeland Security Officers have never mailed to me any warning nor any other additional notices to advise me that I could be detained for that problem and if we refer to the Immigration laws : arresting and detaining an Alien for several months just for a lack of Immigration Status has never been admitted from US Constitution and if they don't have any charge against me , they were not supposed to arrest me at home on January  $10^{\text{th}}2025$  when I was quietly taking my breakfast , eating an apple and drinking some coffee , it was not an attempt to the safety of general population .

Despite the Officers from Homeland Security didn't have any good reason to arrest me, they are unwilling to cooperate with me as I asked them many times to mail me some documentation and a notice mentioning exactly what I got arrested for? Why did they not mail to me any notice of warning prior to arresting me? Why did my french Officer not take any action to help me with my case? (the one from Miami) Why did the Ice Officers not in Atlanta give me a removal notice to sign within my audition on January 10<sup>th</sup> 2025 if they were willing to deport me from United States? Why did they revoke my Visa on October 16<sup>th</sup> 2024 saying I cannot work in United states with the Visa waiver program if USCIS Officers approved my work authorization permit a short time after this? Why am I treated like a criminal, preventing from my freedom and most of my human rights since January 10<sup>th</sup> 2025? Why did they not respect the legal delay of 90 days according to the section in INA 241 (a) and 237 (a)?
