This present letter will be used to complete my previous declaration but more specifically at this time about the ICE Officers of Fort-Lauderdale Airport and even these officers were very kind to release me under my own recognizance I cannot accept that my Visa has been canceled under a lie , I cannot accept to have been threatened and I cannot accept to have been arrested at home almost 3 months later without even having violated any laws of the country .

Custom Officers of Fort-Lauderdale said first of all on October 16<sup>th</sup> 2024 that I wanted to work illegally in United States and that it was a good reason to cancel my touristic Visa , However during my recorded audition I never said that I wanted to work illegally and I never said that I would attempt to work illegally . You can use this recorded audition as proof of lies whose these officers made to ~~cancel~~ illegally my Visa .


Then the chief of managment of this unit decided to put the pressure on me because I refused to get into the plane , It is included in my human rights , to defend myself , and the country , which they wanted to send me back ( Dominican Republic ) is dangerous for me . I was persecuted there by a criminal organization of drug dealers who kept my french passport and made a lot of research about me . They know exactly where I used to live in France , what kind of things I usually did when I was there . Avignon , the city where I come from in France is not very big and they won't have any problem to find me there if you send me back to this country . France is well smaller than USA and anybody can find me there .

I don't want to get the ICE Officers in trouble with the justice even if they threatened me because they were so nice to getting me released from custody after only 2 days and I very appreciated it . ICE Officers of Atlanta don't have been as nice and they mistreated me by denying all my human rights since january 10<sup>th</sup> . I remember that they refused to let me call any lawyer. I have lost my bank account and when the judge will release me from custody I will be lost without even a bank account . It is why I am kindly asking you , with some help from social workers , to helping me when I will get released from custody . I just want a normal life , an apartment and a job , that's it . I am not interested about money or even power . I just want to live my life as a humble people and to have some projects , here in United States .

Subject : Request for Immediate Release or Immediate Deportation

Dear Counsel ,

Firstly , I would like to report an Incident which occurred inside the facility on Thursday 22<sup>nd</sup> 2025 at 4.25 pm precisely with one of the Ice Officer from this facility . I sent a message by using a tablet about 10 am to my Ice Officer stating a legal proposal fight of MMA . I made this proposal without any threats and I told him that he can bring any of the Ice Officers instead of him if he doesn't want to fight . At 4.25 pm , 2 Officers from Ice came to my Unit where I was currently present and threatened me by using intimidation . Fortunately that the camera recorded all the scene ! These Officers are in every way unlawful as they had 90 days to deport me from Stewart Detention Center . After 44 days spent in custody I decided to file an asylum application form I-589 because they are some people whom I have some good reasons to be afraid from . Some evil politicians and cops want me to be locked up just because I insulted some of French Officers ( in France and in other countries ) . I never insult somebody without a good reason and if I insulted some of them it is because most of them are very cruel and they act as they please without taking any consideration for the laws which has been established for the common welfare . These people are rude and selfish and many times my own safety was jeopardized . I must say as example a few words about my French Officer in France who lives in Narbonne and who was in care about my bank account . She decided to close my bank account when I was in Dominican Republic on February 2024 , violating the French policies for the Citizen bank accounts and my human rights .



Ice Officers may think as well that they can do whatever they please without <sup>caring</sup> ~~carrying~~ about the Constitution but Immigration laws state that they have 90 days to deport an alien ~~after~~ <sup>it</sup> from the first day of his confinement in custody . If they want to keep him up to this time , they have to prove either he is a danger for community and will pose some problems or a flight risk . I never tried to flee DHS nor Ice Officers prior to entering in custody and I never was advised by mail service prior to being held by Homeland Security Officers about any warning nor any notice ordering me to fix my Immigration problem . I didn't have the Student Visa which I wished because I was Indigent . Nevertheless my Visa waiver program was supposed to end on January 13<sup>th</sup> 2025 as ~~he~~ <sup>it</sup> allowed me a right to stay 90 days within the country . My Visa has been revoked under a lie on October 16<sup>th</sup> 2024 as the Officer who made my First audition of entrance hasn't been honest with me , saying that I wished to work illegally and stating within the report that I answered : " From an employer " to the following question : " From who do you expect to get an authorization to work ? " . The correct answer was : " From French Embassy " . This Officer lied to revoke my Visa . On October 17<sup>th</sup> 2024 , the Chief of that unit~~x~~ came to my cell with 2 other Ice Officers and threatened me by saying : " You will get into that fucking plane and there is not other choices . If you don't want to , we are going to break your neck " . They decided to release me on the same day after a real fear to go back to Dominican Republic which I claimed . This country was not my native country but for some unknown reasons , it was the designated country for my deportation . In that country I was a victim of persecution from a Criminal International traffic .

A short time after my release , I advised my French Officer in Miami ( Mrs Bourgin Rebecca ) who of course denied all my requests for legal assistance as I have ever received some assistance in other countries from some other French Embassy and Consulate Officers , in the past . I am stating as example the French Officer in Morocco , Agadir , about Winter 2021 . I remember the great and <sup>quite</sup> ~~quite~~ house which I rent to stay in Agadir and got from a Taxi Driver who I met at my arrival in the Airport . It was my first vacation out of Europe and probably one of the Best ! There was the Sun all the time , a lot of warm and some Horses running upon the sand at the beach . I was feeling so happy as I was in connection with the Nature , without any electronic devices ( except my phone ) just relaxing myself and discovering the country . During the day I was running outside , alone through the mountains and at the night , reading a lot . I got my first politician book which I bought within the French Airport prior to flying to Morocco . It was a book about Donald trump , there were so much information over him , his life , his career ! Politicians from United States describe him as a Sociopath !



When I got deported from Morocco to Paris , due to Covid-19 I dwelt within the City for 2 or 3 months , then I got bored and went into the South of France ( Marseille , Nice ) . As I remember , leaving Nice on Summer 2022 to go to Aix-en-Provence which is probably one of the best town of France ( a town near to Marseille ) . I have been also to Charleville-Meziere , Reims , Toulouse , Avignon , Toulon , Monaco . As I remember on 2022 I usually went to Italy which is very near to Nice to learn some Italian culture and the language . I was studying Italian at the University ( Sophia Antipolis ) , in Nice . Italy is one of the best country ( in Europe ) There were so much delicious Pizza and some good juice and the architecture of the following cities is very beautiful ( Milan , Turin , Genova , Rome ) . I have spent most of my Life to travel alone and escape from a truth which is difficult to accept : which one of Death ! Because one day we will all die and I am questioning myself a lot about the meaning of Life since I was a child . What are we living for if it is to die in the end ?

My mother passed away on August 27<sup>th</sup> 2020 . From Summer 2018 to Summer 2020 I was happy , dwelling in Toulouse and working for a prestigious company . My job was about visiting the customers at home and trying to find some agreements to convince them to change their contract and swich their company of electricity for the one whose I represented . I was not worried about Death on this time , this job was so pleasant and I got a very good team ! But a few days after my mother passed away : I thought about death every days , It was the beginning of Melancholy. I went to French Army as a soldier in Verdun on September 2020 but I didn't respect the contract which I signed with the army as I was supposed to stay 2 years with that unity and dwelt only one month . I left army due to Depression and I started being errant , in need of freedom , feeling myself alone and sad .

I am honest and I never lied to Ice Officers neither in Fort-Lauderdale nor in Atlanta . Why are you keeping me locked up like a criminal , like an animal since January 10<sup>th</sup> 2025 just for a problem with my legal status ? I asked for a parole request on March 6<sup>th</sup> 2025 to US Government Officers ( DHS ) which never got any answer . Why did you revoke my order of recognizance enacted by Ice Officers from Fort-Lauderdale as I never commit any crime or felony from October 16<sup>th</sup> 2024 to January 10<sup>th</sup> 2025 ? Why did you not care about all the rights things I <sup>did</sup> made to be legal ( with my USCIS Account ) ? I am kindly requesting you to stop this persecution and to let me go back to home in Atlanta or send me back to France if you are unwilling to accept me within United States . I spent a lot of time in custody and I don't want to deal with this situation anymore .

Please just let me go !
