First of all I would like to remind you that I have spent about 155 days inside Stewart Detention Center for no reason . As I want to remind you also that I didn't commit any crime or felony in United States nor having pleaded guilty for anything . However I got caught by ICE Officers arbitrarily without any good reason to do it when I was at home , in Atlanta . Since that time , some reliefs are still on pending with my case and it's look like nothing is moving forward and I am still stuck inside the Facility where I am currently struggling with Depression . Does it is a crime to seek asylum in United States that they want to keep me locked up for several months , like a criminal , like an animal ? My Ice Officer : Mr Bush David pointed out the only argument that I madean appeal with my asylum proceedings to justify that Illegal Detention . It is enough right now and I don't have to deal with this situation any more . If they don't want to release me from custody and continue to violate all the laws of the country , I agree to be removed ! I have sent multiple messages with the tablet to advise my ICE Officer that I would not await quietly inside the facility about additional several months and instead of this I want him to deport me if he is unwilling to release me on O/R or with a bond . I don't have the certitude that making an appeal does allow them to keep me in custody up to 6 months (under which law ?) but if my ICE Officer tells Truth I would better like to be removed .

My ICE Officer harmed me enough and wasted the time of my life as well. Immigration laws state that those animals are not supposed to keep me locked-up any longer than a reasonable period of 6 months but as I understood that he clearly expressed the wish to exceed this time so I cannot deal with that! I guess how much it might be hard for you to understand the Pain and the Distress of dwelling as much time locked up inside that place. I cannot deal with them any more, they are animals and they want me to choose among these 3 following choices:

- 1) fighting my case further and accepting to stay again for several additional months in custody
- 2) accepting a final order of removal even if I did nothing wrong or against the laws
- 3) killing myself in according to the will of those persecutors

It might be perceived as exaggerated and utterly disconnected from reality but you have to know that an alien inside the same facility killed himself in unit 4 a couple of weeks ago because he was also persecuted by his ICE Officer. Those persons are very ruthless and cruel and do all they can do to keep the detainees as much time as possible inside the facility. It was not a great surprise when my ICE Officer advised me that He will exceed the 6 months legal period of Detention using the only following argument: I have an appeal on pending! As I claimed since January 2025 that He was willing to use all the argumentation and lies that He may use to pursue with my Illegal Detention. How much time those evil and stupid animals are they going to keep me locked up against my will? How much time? There is not any law to permit it and as I explained multiples times, I don't want to stay further in custody !!!!!! The terrorists want to force me to choose among the 3 proposals listed above and each of these choices would please them: If I accept a final order of removal they will enjoy it as they tortured me by keeping me locked up against my will all this time and then will deport me to my country as if nothing happened. If ICE Officers like so much to lock up people for no reason, why don't those stupid persons send their own mothers inside a facility? If I wish further to fight for my case, those persecutors would be happy as well because they will use the only argument that I am currently applying for a relief to keep me up to 1 year in Detention . As if either seeking for reliefs or asylum was a crime in United States . If I choose to kill my self, they will be also happy because they are persecuting me since January 10th 2025 in total impunity (Since Interpol wrote a notice emphasizing that I probably harassed a French Officer living here, in United States.) They enacted a warrant without any proof of harassment, just because Mrs Bourgin Rebecca, my French council of Miami bemoaned about me, I send her about 40 emails (from June 2024 to January 2025) to seek some legal assistance.

I requested a legal Prosecution to Federal Bureau of Investigation against Mrs Bourgin Rebecca (for the lies) and against Mr Bush David (for this continued Detention, Harm and Persecution) and after all this time spent in custody, I claim there is not any laws, in United States, mentioning the consent of keeping any Alien against his will so much time despite the lack of criminal charges. I am sorry to tell those Son of Bit**** who work for ICE that I am not going to kill my self and I am ready to face those persecutors before a judge in a criminal court because as I want to remind that Persecution and Harm are not permitted in Democracy! I want to fight and raise for Justice. ICE Officers are Murderers, Persecutors, Harassers and they shall be locked up instead of me. So I have spent enough time locked up like a criminal and I am legally requesting to recover my freedom as I never violated any law and I want to tell ICE Officers that they can do whatever they please to harm me further that they will never be able to destroy me! I am smarter and stronger than those animals animals, those terrorists. If American leaders are thinking to be allowed do whatever they please, they shall be aware that all the mistreatment for which I am targeted from US Government, will be reported also to other International agencies (Including the ones that care about Torture). They don't have any jurisdiction nor right to torture me by keeping me locked up as much time and preventing me from sleeping at night as the Officers let the light up until 4am . I have been traveling into multiple other countries and I have never been tortured like this (except by American Leaders) They are persecuting me for no reason, I didn't do anything to deserve it! I am kindly asking you either to accelerate the process and move drastically forward with my case or enact an order of removal that I can return to my country even if there is a risk of Harm . I would better like to be tortured and locked up in France rather than United States.

Finally, I am going to conclude this brief by saying a few word about the Officer Gonzalez who made my audition on October 16th 2024 because I though she lied only one time when she said that I replied: "an employer "instead of "French Embassy" to the following question: "From who do you expect to get a permission to work?" Nonetheless after having reviewed the report I pointed out an other lie: She expressed and emphasized that I was "currently seeking for an employment "in United States. However I never stated during that hearing that I was " currently seeking for an employment " and instead of this I said that I would work only after having got a permission from the French Embassy. There is a significant difference between saying: "I am currently seeking for an employment" and "I will work after having got a permission ". I am willing to let the F.B.I investigate and acknowledge about it and all those Officers who work for ICE shall agree with the rules and policy of the country. It is not because they work for US Government that they are allowed to lie, Harm and Persecute. I am currently asking further Prosecution against the Officer Gonzalez as well because lying over a declaration to get somebody in trouble is a true violation of the laws enacted within the Constitution. The Officer Gonzalez revoked my Visa waiver program saying that I have violated the Immigration laws but I didn't do anything wrong. As a victim of Persecution I am permitted and request to Appear before a judge to talk further about it and I am also permitted to be protected from my Persecutors: My current ICE Officer and my French council who works in Miami . I Have also the right to recover my Freedom after 6 months spent in custody with Habeas Corpus Petition, which means: within 25 days
