Subject: Re-edition and correction of the Brief written on May 12th 2025

Firslty, I would like to fix an error that I made within the previous letter dated on May 1st 2025. I mistakenly stated that I entered the Dominican Republic on December 2024, but on December 2024 I was in Atlanta, GA, in the United States. I left France on December 8th 2023, and I entered the Dominican Republic (Port of Santo-Domingo) around December 22nd 2023. It was my third time on a ship. My first time was on June 2022 to London (from Calais), then to Estonia from Finland about September 2022. The trip to London and the one to Estonia were only about a couple of hours by sea. The one to Dominican Republic in departure from the port of Marseille was about a couple of weeks, going through the Ocean. I remember the good food and the good ambiance within my last cruise to Dominican Republic. There were some fish, meat, good vegetables, orange juice, nice cakes with a lot of chocolate and a lot of cheese. I traveled alone without friends or family, I felt myself so incredibly free, traveling into the world and realizing all my wishes. I met some great people during the trip and there were many families, mostly from Italy. That voyage occurred about 10 months after I got deported from Uzbekistan (Tashkent) to Paris, forced and accompanied with 2 doctors inside the plane. On March 2023, after having been held around 40 days inside a psychiatric hospital in Tashkent against my will, I finally was deported under escort of these doctors.

On January 2023, I was free within Tahkent, but I developed some indigent problems, and I had to go to the French embassy to ask for some assistance because I couldn't pay for the hotel anymore. The French officers of that embassy got me into a trap saying there were only 2 options: either I accepted to follow the doctors to the hospital or get out of the French embassy with neither assistance nor money and sleep outside, on the ground. The French officers said I was mad because I usually traveled into the world with a limited budget and because I sent them some e-mails with a bit of sarcasm wherein I stated that I was the Pharaoh and the king of Egypt. Those officers do not accept this kind of joke, but I did it for a good reason: I just wished to remind these people that freedom of speech as to be preserved as it is included within my human rights. The doctors got me out of the hospital and took me to Frankfurt in Germany, forcing me to get into a first plane with them. I was supposed to get into a second plane from Frankfurt to Paris with these same doctors, but I refused to get into the second one, and police officers of Germany reminded them that they were not allowed to force me to get into a plane against my will. I got into the train from Frankfurt without the doctors and went back to France (Metz), where I dwelt for 6 weeks before going back to Narbonne.

Fortunately, I made the right decision when I refused to get into the second plane because the French officers were waiting for me at the arrival with a lot of doctors to force me to go into another psychiatric clinic, in Paris. This was not the only time that French officers tried to keep me locked-up against my will, and they do not hesitate to lie to the authorities to accomplish that purpose. They lied to the doctors, saying I was mad and they cannot agree with my political opinions, it is the main reason of such a persecution! The freedom of speech has a brim, and it is not permitted to support any criminal or terrorist organization. However, just because I told them that I was the Pharaoh and the king of Egypt, that does not mean they were allowed to deny all my legal requests for assistance in Tashkent and put me in a psychiatric clinic against my will. I have seen a lot of bad things inside this place, the doctors sometimes assaulted the patients and gave them a lot of drugs and cigarettes to make them mad... The officers of the French embassy were not allowed to get me out of Uzbekistan as I didn't exceed the lawful right of stay permitted without a Visa, which means 30 days. When I went to the French embassy, I had only spent a couple of weeks within the country and I had never committed any crime or felony in Uzbekistan. What they did was illegal... Prior to entering Uzbekistan, I dwelt around 44 days in Kazakhstan (Astana and Almaty), and prior entering Kazakhstan I dwelt around 40 days in Russia (Saint-Petersburg, Moscow and Omsk). Prior to entering Russia, I dwelt around 100 days in Estonia and prior to entering Estonia, I was in Finland for about 5 weeks (in Helsinki). I stayed around 4 weeks in Sweden and a bit longer than a couple of weeks in Denmark (where I lost my French passport inside a homeless shelter) prior to getting into the train to Finland (without any money). I was sometimes forced to sleep outside, but I do not regret anything and it was a good adventure. I made all this trip alone and with a very limited budget.

On August 2023, after having spent some time in Metz and Narbonne, I decided to go back to Avignon in France where my friend is currently living, and I stayed with him for about 4 months, seeking and applying for some job opportunities. It was on summer and the famous festival took place as well (which attracts a lot of tourists each year). I met my girlfriend on July 2023 (when I was still living in Narbonne, a few time before going to Avignon), in Montpellier, a city near to Narbonne. I went often there when I was living in Narbonne because Montpellier is bigger and there are more opportunities within this city. Once, near to the main place of Montpellier town-center (place de la comedie), I saw this beautiful blond girl who was walking alone and decided to get out of the tramway and go to talk to her . A short time after this , I had a meeting with that woman in Agde where we went into a natural hidden place and drunk a little bit of good wine! When I advised her about my wish of leaving France and going to United States by sea, she replied: "Oh my God, you are so crazy ! " She said it because I made that decision hastily without even planning anything . I went to Dominican Republic to get closer to United States as I was not able to stay inside a plane for 9 hours in a row (phobia) and I decided rather to reserve a place on the ship to Saint-Domingue because there was not any departure to United States with the cruise at this time. Once, I have been deported from Turkey too, about June 2022 because I exceeded the legal delay of 90 days of stay in the country, permitted without any Visa and I was caught at the border with Iran on May 2022.

I stayed in Turkey from January 2022 to June 2022 and I was so lucky because I was in Ukraine too from November 2021 to January 2022 (a few time before the war was coming up). I got a flight with the help of Kharkov French consulate because I was also indigent in Ukraine. The plane did not go directly to Paris, so I got into the first plane to Istanbul and was supposed to get into the second one in departure from Istanbul to Paris. Instead of this, I decided to dwell in Turkey for awhile because this kind of trip makes me feel happy and because I am so scared about the plane. I stayed for 6 weeks in Istanbul then around 10 days in Ankara. After this, I came back to Istanbul because I got some strong fellowships in that city. Then I went to Antalya (the best city of Turkey) where I dwelt for a couple of months before going to Alanya, Mersin and going through some other cities en route.

When I went to Paris, after the deportation from Turkey on June 21st 2022, I immediately reported to police officers of France that I was planning to travel to London. One of the officers among the staff said that I was very lucky and got a good life, saying I was a real "Globe trotter". Another officer from this unit was joking because there was a lot of rain in Paris, on this day and it was the first day of Summer! After my departure from the police office on the same day, I went to the Paris train station (Gare du Nord) to go to Lille, then Calais where I spent the night inside a Inn, awaiting for the next available ship to England. I immediately took the bus and then the train to London after my arrival in the country by sea. I visited the capital of England for approximately 8 days and I very enjoyed it! I will go back, for sure!

I will talk further about my trips, but to conclude this brief I will say a few words about the proceedings, and I am requesting an attorney, because I tried to get one by myself but all my legal requests to achieve this purpose have been denied. After more than 166 days inside the Stewart detention center, I really need to be represented. All my human rights have been denied since January 10th 2025. The officer Gonzalez Amberly who made my first interview of admission, in Fort-Lauderdale, on October 16th 2024, voluntarily lied over the declaration stating upon the notice that I replied: "from an employer "to the following question: "From who do you expect to get an authorization to work?". I never replied: "from an employer "and instead of this the correct response was: "from the French embassy". This officer might be aware that lying over a declaration to get somebody in troubles with the immigration laws is a crime in the United States and I require a legal prosecution about what she did. If I am lucky enough, this Interview was recorded and the F.B.I. Officers will be able to listen it

I want to conclude this brief by reminding that the Immigration laws state that the reasonable period of imprisonment must not exceed 6 months except if the detainee may represent a reel risk or danger for the community. All the arguments from Mr Bush David, trying to extend this time saying that I may be a flight risk, are unacceptable. Torture and persecution are not permitted in the "democracy of the United States" and instead of stubbornly wishing to harm me further and keep me as much time as possible in custody, this officer shall be graceful enough about the luck he got of being born in United States and he shall respect the laws enacted within the Constitution. I BEMOAN AGAINST MR BUSH DAVID AND MRS BOURGIN REBECCA ABOUT EMOTIONAL HARM, ILLEGAL DETENTION AND PERSECUTION. These people are very cruel and insane and I still don't understand why they have so much power and jurisdiction. They are using their influence to keep me as much time as possible inside the facility. They will use all the tricks and lies to accomplish their purpose insidiously (without being unmasked) because these stupids people want only one thing: get the satisfaction of harming and persecuting somebody, that they consider as being an enemy.
