JOINT STATUS REPORT

The parties respectfully submit the following status report in compliance with this Court's order:

By agreement of the parties and order of this Court, this matter is currently stayed and administratively closed pending the final outcome of *W.M.M. v. Trump*, No. 25-10534, 2025 WL 2508869 (5th Cir. Sept. 2, 2025), *vacated by W.M.M. v. Trump*, No. 25-10534, 154 F.4th 319 (5th Cir. Sept. 30, 2025).

On September 2, 2025, the Fifth Circuit Court of Appeals held, in relevant part, the petitioners are "likely to succeed in demonstrating that the Proclamation cannot be supported either by the existence of a declared war or an invasion," and the Court granted a preliminary injunction blocking removal and remanded the matter to the district court for further proceedings consistent with its order. *See W.M.M.*, 154 F4th at 321. On September 30, 2025, the Fifth Circuit granted the government's petition for an *en banc* rehearing and vacated the panel opinion. *See id.* The oral arguments are scheduled before the *en banc* Fifth Circuit for January 22, 2026.

The Petitioner, Mr. JIMENEZ BRACHO, is currently subject to administratively closed removal proceedings before the Executive Office for Immigration Review (EOIR), where he has

a pending application for asylum and withholding of removal. The United States Citizenship and Immigration Services (USCIS) has withdrawn Mr. JIMENEZ BRACHO's Temporary Protected Status.

The parties agree to keep this matter stayed until resolution of *W.M.M. v. Trump*, No. 25-10534, which is currently pending the *en banc* rehearing before the Fifth Circuit Court of Appeals. Oral arguments are scheduled for **January 22, 2026**.
