PRELIMINARY INJUNCTION

PLEASE TAKE NOTICE THAT Petitioner Horacio Munoz-Saucedo, through undersigned counsel, will move before the Honorable Judge Christine O'Hearn, United States District Court for the District of New Jersey, for a temporary restraining order (TRO) or preliminary injunction (PI) directing respondents to immediately release him from custody.
