Pursuant to this Court's Order (Dkt. No. 16), Federal Respondent U.S. Immigration and Customs Enforcement ("ICE") provides this status update concerning Petitioner Tareq Ziad Fouad Zakarneh's detention status. On or about June 6, 2025, ICE transferred Petitioner to another ICE facility in preparation for removal. Supplemental Declaration of Enrique Rodriguez, ¶¶ 4, 5. Although a previously scheduled removal flight was cancelled (Id., ¶ 6), there is a significant likelihood of Petitioner's removal to be scheduled in the foreseeable future. Id., ¶ 9. Petitioner is being detained at the El Paso Service Processing Center in El Paso, Texas, awaiting a removal flight. Id., ¶¶ 7, 8.
