Klein and officer Kury and Garcia neglect any knowledge of these orders and court filing as they refused to collaborate and comply with the Deferred Enforcement Departure order of Biden and Trump administrations for Palestinians , as the plaintiff does not get a clear answer from ICE why the process has been terminated at the airport of Dallas Texas under two reasons, first the Deportations officers alleged that the Plaintiff does not have the proper document and the proper country to be deported to, as on June,13,2025 the Deportation officer alleged that the war between Israel and Iran has been escalated and they were not able to deport any Palestinian .

The Plaintiff prayers to grant his motion to force the DHS and its forces to follow the orders and citations that has been issued for humanitarian reasons.



Please see the attached motions with this letter after the US custom enforcement and the detention center of GEO corporation lost my property, I want to inform the court that I filed the attached motions on June, 17,2025 when I was in Prairie land Detention Center At Alvarado Texas, unfortunately the detention center was prejudice and we got in argument about my lost property and they did not provide me with my law library work too before ICE fly me back to Arizona Facility on June,30,25 then fly me back to Tacoma, Wa on July.1.2025, but after my immigration lawyer Eric Welsh report a complaint on June,27,2025 to the BIA an investigation that has been opened by the Board Of Immigration of Appeal with the US Immigration Custom Enforcement, the Immigration Custom Enforcement was going fast to send me back to my original location at Tacoma, WA of the NW ICE processing center without locating my property and my work at the law library, Please see these motion but it still missing my declaration under penalty and perjury, as it can't be filed yet without the declaration , but according to my trust account it was mailed on June,20,2025 from Prairie Land Detention Center in Alvarado, TX, the respondent has the possession on my mail and it was responsible about mailing it because at that moment my account was between 14 dollar to 16 dollar which it makes the respondent responsible about covering the mailing fees but I was able to see a charge to my trust account and a refund too of two transaction of \$2.31, hopefully the court will got the filing soon without obstruction from the respondent.

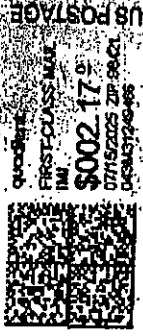
