

23 Pursuant to this Court's Order (Dkt. No. 43), Federal Respondent submits this response to
24 Petitioner Tareq Ziad Fouad Zakarneh's motion to release his legal work. Dkt. No. 35 ("Mot."
Or "Motion"). Petitioner alleges that due to various transfers, the government has misplaced his
legal property since June 6, 2025. Mot., at 2. The Motion should be denied as U.S. Immigration
and Customs Enforcement has located and returned Petitioner's property. Supplemental
Declaration of Daniel Strzelczyk, ¶ 6.

Accordingly, Petitioner's Motion should be denied as moot. *See Foster v. Carson*, 346
F.3d 742, 745 (9th Cir. 2003).
