PLEASE NOTE that the Applicant is detained and unable to provide passport-sized photographs.

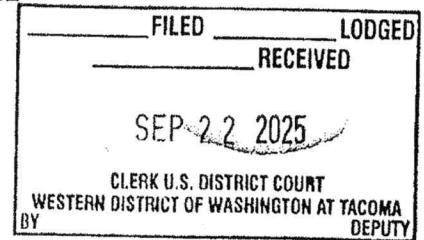
