HABEAS CORPUS

Comes now Mark and request this court order Immigration and Customs Enforcement (ICE) to bring forth my wife Mandy Helstrom and to show cause why she is being held, my wife and myself filed the proper paper work about 25 years ago and she was approved to stay and become and American, my wife in the 25 years of living in this country has never been convicted of any crime, this detention is inappropriate, ice has been moving her from one facility to another without charges. I have spoken to the Immigration Court in Kansas and they have informed me that no charges have been filed and they also informed me that what is going on is irregular and is not proper procedures.

ICE has refused to provide any information for the detention, ICE has also said to my wife that; "she is not entitled to a court hearing" we must move swiftly to prevent and further illegal deportations as the United States Supreme Court ruled in a unanimous 9-0 ruling, the court ordered the Trump administration to "facilitate" the return of Kilmar Ábrego García, a man who was deported to El Salvador after being improperly deported. The court ruled it was a violation of Due process and he was denied access to the courts, as what is happening in this case as my wife is being told that she is not entitle to have a hearing on this matter, my wife has been incarcerated since May 6 of 2025. This is an illegal detention, because, she filled out all the proper paper work and was granted the right to stay and become an American. This is placing undue burden on my life as my wife and my self are never apart, this is the longest we have been apart, this is undue stress on us, Immigration and Customs Enforcement is trying to destroy are marriage of 26 years.

When I talked to the Immigration Court, they concurred that my wife should have never been taken into custody and she should have been informed of any paperwork that need to be completed for her to become an American. The Immigration Court informed me they cannot act until such time as ICE files in the court and ICE is just moving her all over without filing in the court. this is why I have filed this Habeas Corpus; This is an unjust detention and is placing undue stress on my wife and my self.

This court must move swiftly and prevent any further harm and from ICE removing my wife without a court hearing. I respectfully request the release of my wife and for her safe passage back from where she was taken. My wife is no flight risk and she has never harmed anybody.

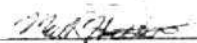
