## **DEFENDANTS' NOTICE OF ERRATA**

Defendants respectfully submit this errata in relation to Defendants' Response to Petitioner's Motion for a Temporary Restraining Order (ECF 12) filed on May 27, 2025. The corrected Response changes the language of Footnote Two. The original language of footnote reads:

Petitioner's reliance on § 22 is out of step with reality. The 1836 treaty clearly is only in force where the alien is not chargeable with actual hostility, but the Proclamation by its terms rules this out by recognizing hostile acts. *See, e.g.*, ECF No. 1 at 85-87.

The corrected language reads:

The obligations under Article 26 of the 1836 treaty clearly only apply where the alien has not committed conduct that causes them to forfeit the protection of the treaty, but the Proclamation by its terms rules this out by finding and declaring that [those subject to the proclamation are/all members of TdA are, by virtue of their membership in that organization,] chargeable with actual hostility.

The corrected Response contains no other changes.
