EMERGENCY MOTION FOR IMMEDIATE RELEASE

EMERGENCY PETITION FOR WRIT OF HABEAS CORPUS

Petitioner Wending Mai, by and through his Next Friend, Huan Wang, respectfully petitions this Honorable Court for a Writ of Habeas Corpus pursuant to 28 U.S.C. § 2241 and moves for his immediate release based on the following grounds:

#### I. INTRODUCTION

Petitioner Wending Mai is currently unlawfully detained by ICE.
