PLAINTIFF’S RESPONSE TO ORDER TO SHOW CAUSE

Comes now the Petitioner, Bryan Fabricio Ramos Hernandez, by counsel, and respectfully files his Response to the Court’s Order to Show Cause, entered on October 10, 2025, which contemplates dismissal of the pending Petition for Writ of Habeas Corpus for Petitioner having failed to effect service of process on the Respondents.
