Petition for issuance of a court order

Habeas Corpus in accordance with 28 U.S.C. § 2241

I Kordzaia Teimuraz, hereby request the court issue a writ of Habeas Corpus, as I believe my detention by the Immigration and Customs Enforcement Service (ICE) is unlawful.

1. I my wife and two children (DOB 2011 and 2023) crossed the United States border at the Brownsville port of entry on November 11, 2024 at a pre-arranged time using the CBP-One application to request political asylum, and were subsequently separated from my family and placed in El Valle Detention Facility on November 6, 2024 were I am to this day, that is, more than 200 days.
2. I do not have a final deportation order, but despite this, I continue to be held without the possibility of release on bail or supervision.
3. There were serious violations in my case, including:

During the interview to determine of persecution or torture, due to incorrect translation and misunderstanding, data was entered that did not correspond to reality, which led to a negative decision.

The immigration judge upheld this decision on November 18, 2024 and I was not given the opportunity to appear before the court and provide evidence in my case.

My application for asylum i589 was denied while mu wife's application for asylum i589 which included me and our children was approved and a trail in immigration court was scheduled for the above case.

At this time, I do not have the opportunity to join the case in court with my family, since we are under the jurisdiction of different states.

Deportation to Russia in the foreseeable future is not possible due to the poor political situation in the country, and in the event of a return to Russia, my family and I, our lives, health and freedom are imminent danger, we are being persecuted by the Russian authorities for our political opinion.

There has been no action on my case for over 180 days, ICE has not responded to my requests, my wife's requests, my attorney's requests, did not respond to a request to meet with the officer handling my case.

My detention was not subject to administrative review, I was not provided any documents during the entire period.

My case is being delayed without cause, ICE is holding me in detention without cause and violating my rights under the Supreme Court decision "*Zadvydas v. Davis* (2001)"

Based on the above, I ask court to:

- Declare my detention unlawful;
- Release me on bail or otherwise;
- Give me the opportunity to reunite with my family and consolidate our case in court.

In connection with my possible transfer another place of detention, I additionally ask you to provide an answer to my wife:


