I was just informed by Mr. Perez that due to a an incident at Delaney Hall, many of the prisoners, including he, are immediately being transferred to Texas.

While we appreciate the facility's institutional imperatives, we do not think that this is the appropriate solution for Mr. Perez, especially in line of your Honor's recent order and the brief history of this matter.

May I ask the Court to ask Mr. Sun, to make sure that your Your Honor' ruling is strictly adhered to, even in this context?

I apologize for burdening the Court with this additional detail, but I thought the issue needed to be immediately addressed before there were further transfers and re-transfers in the making.
