## PETITIONER'S EMERGENCY MOTION FOR A TEMPORARY RESTRAINING ORDER AND/OR PRELIMINARY INJUNCTION

Petitioner, Douglas Menjivar, through his undersigned Counsel, moves under the Federal Rules of Civil Procedure 65 for the following temporary restraining order and preliminary injunction against all Defendants:

- 1. Grant his Motion for Emergency Motion for Temporary Restraining Order and/or Preliminary Injunction.
- Enter an Order continuing to enjoining Defendants and their agents from removing him from the United States until further order of the Court; and
- 3. Grant him such other, further and additional relief as the Court deems just and appropriate.

In support of his Motion, Petitioner relies on the accompanying Brief in Support, including any attached exhibits, and his Petition for Habeas Corpus relief. (ECF # 1)
