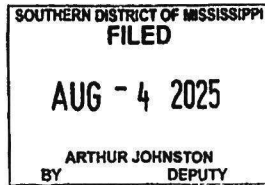

Due to new circumstances I am again asking and requesting you for:

1. reaction in my case and expedite in my case
2. stop removal procedures issued against me which are in effects of the conspire and illegal activity organized against me;
3. for release me from this unreasonable and unauthorized detention and for allow me to access and secure my things and my belongings which are left by the party in the case which want rob me in the hotel room. These are my personal things, documents, IDs. Legal documents, my work, my clothes, my pictures, my family pictures, my child pictures and documents, my native phone with pictures and data, my laptop with my work and data, and other things.

Simultaneously, I am asking you repeatedly for reaction and for orders in response to my motions and requests. I really need your reaction and support, in the reported conspire against to the U.S. Federal law and to the U.S. Federal government is involved judge which is working with the and over the detention facility. They want send me back to the people who were persecuting me and torturing during years before I arrive in the USA, They are using for that purpose a fictional and false documents and documentations. What is mentioned above, they did left my belongings in the hotel room and they want rob them. They did not allow me to pay my bills and financial obligations, including in my native country which I have, and I have now a seriously financial and legal implications in result of their conspire and that behaviors. They put me into detention using false and fictional documents and documentation. And everything is completely unreasonable and without even authority. I didn't violate a law, I didn't committed a crime. (what's more I did prove a crime and it include an illegal activity against to the U.S. Government, U.S. Taxpayers, U.S. Federal institutions, and I am a victim of the crime). They are conspiring because facility authorities and state local federal governmental workers (e.g. ICE officers, Judges), are detaining peoples using false and fictional documents and documentation, they are generating fictional costs to the U.S. Government and to the U.S. Taxpayers, and are doing that for financial benefits and for money.

Currently (with the judge) they want force me to the drugs, they want intoxicate me, and they want separating and isolating me, because I am issuing these facts, these illegal activities, these completely unreasonable and unauthorized detention, and these damages they are affecting to me and to my dependents. I am legally present in the USA. I didn't nothing against tot he USA or U.S. Citizens.
