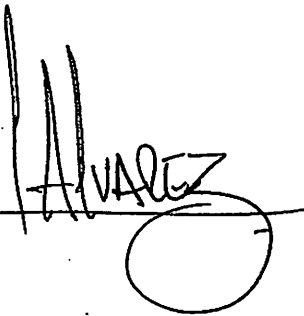
- EMERGENCY PETITION TO STOP MY DEPORTATION TO MEXICO,

DETENTION CENTER IN LUMPKIN, GA. ON JULY 17, 2025, I WAS
SERVED WITH A NOTICE OF REMOVAL BY THE ICE OFFICES FOR AN
ATTEMPT TO REMOVE ME TO MEXICO.

I ASK YOUR HONOR TO DISMISS THIS ORDER FOR THE
FOLLOWING REASONS;

- 1-) I AM CUBAN CITIZEN. BORN IN CUBA.
- 2-) I HAVE NEVER HAD ANY TIES TO OR TRANSITED THROUGH
MEXICO.
- 3-) ICE HAS NOT YET PRESENTED ME WITH ANY DOCUMENT
NOTIFYING ME, THAT MEXICO WILL ACCEPT MY DEPORTATION
TO MEXICAN TERRITORY, IT HAS NOT GIVEN ME ANY GUARANTEE
FOR MY PHYSICAL OR MEDICAL SAFETY DURING MY STAY IN
MEXICO.

IF I AM TO BE REMOVED TO A COUNTRY OTHER THAN CUBA, I ASK FOR THE MINIMUM GUARANTEE FROM THE GOVERNMENT IN QUESTION, THIS IS A CLEAR VIOLATION OF MY CIVIL RIGHTS, SO I ASK YOUR HONOR TO HALT THIS. ATTEMPT TO REMOVE ME TO MEXICO OR ANY COUNTRY UNTIL I AM GIVEN THE MINIMUM GUARANTEES FOR MY FUTURE. RESPECTFULLY, THIS JULY 17, 2025.

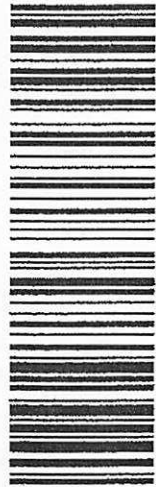
