I HAVE ALL MY WORK PAPER AND FORM I-360 RECEIPT NUMBER EA [REDACTED] AND FORM I-765 RECEIPT NUMBER M [REDACTED] AND FORM I-601 RECEIPT NUMBER EA [REDACTED]. AND I REPORT WITH I.C.E. OFFICE AND MY COUNTRY ISRAEL WAR.

I'm With I.C.E detained from 6/4/2025. Because the lie to me to come to office due to interview my work paper and soon I arrive with all my respect and all my trust they detained me.

Without any respect the law that I'm waiting i-360 and I have business that now I lost everything because one woman officer has hate racism.

I'm kind asking you please release me under Removed pursuant to proceedings commenced on or after 1, 1997.

Because the agency has not affected your deportation or removal during the period prescribed by law, what is placed under supervision and permitted to be at large under the following conditions:

That I appear in person at the time and place specified, upon each and every request of the agency, for identification and for deportation or removal.

That upon request of the agency, I appear for medical or psychiatric examination at the expense of the United States government.

That I provide information under oath about my nationality, circumstances, habit, association and activities and such other information as information as the agency considers appropriate.

That I do not travel outside the state of Florida for more than 48 hours without first having notified this agency office of the dates and places. And obtaining approval from this agency office of such proposed travel.

That I furnish written notice to this agency office of any change of residence or employment 48 hour prior to such change.

That I will report in person on to this agency office at: I.C.E Orlando FL 32837.

That I do not associate with known gang members, criminal associates, or be associated with any such activity.

That I do not commit any crimes while on this order of supervision.

That I provide I.C.E with written copies or request to Embassies or consulates requesting the issuance of a travel document.

Any violation of the above conditions will result in revocation of your employment authorization document.

Any violation of these conditions may result in you being taken into service custody and being criminally prosecuted.

I'm kindly asking you please release me under Removed pursuant to proceedings commenced on or after 1, 1997. And always following and respect your order.

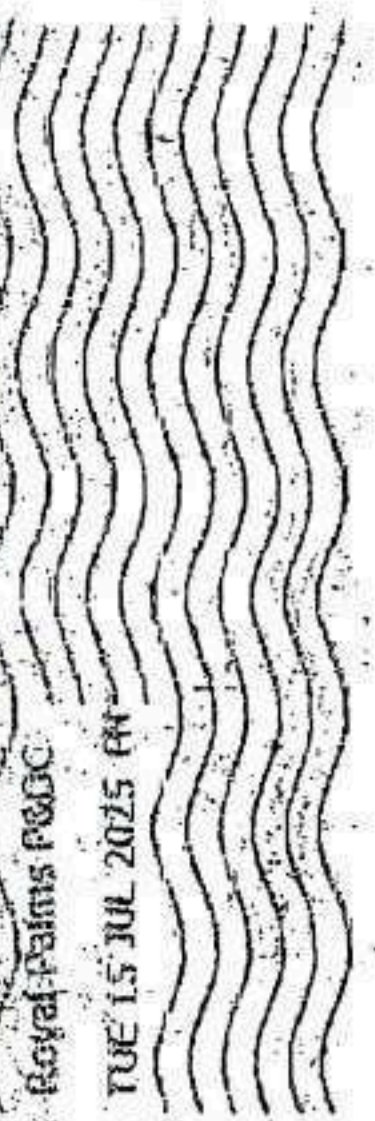
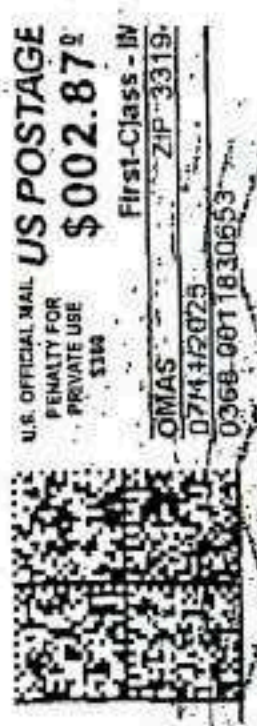
The Officer Christian she work in I.C.E and what hurt she come night before to transfer me to Miami to come to see me how I'm down hurt in the jail.
