Notice of Revocation of Release

You will promptly be afforded an informal interview at which you will be given the opportunity to respond to the reasons for the revocation and to provide any evidence to demonstrate that your removal is unlikely. If you are not released following the informal interview, you will receive notification of a new review, which will occur within approximately three months from the date of this notice.

You are advised that you must demonstrate that you are making reasonable efforts to comply with the order of removal, and that you are cooperating with the ICE's efforts to remove you by taking whatever actions ICE requests to effect your removal. You are also advised that any willful failure or refusal on your part to make timely application in good faith for travel or other documents necessary for your departure, or any conspiracy or actions to prevent your removal or obstruct the issuance of a travel document, may subject you to criminal prosecution under 8 USC Section 1253(a).



Notice to Alien of File Custody Review

You are detained in the custody of U.S. Immigration and Customs Enforcement (ICE) and you are required to cooperate with ICE in effecting your removal from the United States. Your custody status will be reviewed on or about 09/01/2025. The Deciding Official may consider, but is not limited to considering the following:

- 1. Criminal convictions and criminal conduct;
- 2. Other criminal and immigration history;
- 3. Sentence(s) imposed and time actually served;
- 4. History of escapes, failures to appear for judicial or other proceedings, and other defaults;
- 5. Probation history;
- 6. Disciplinary problems while incarcerated;
- 7. Evidence of rehabilitative effort or recidivism;
- 8. Equities in the United States;
- 9. Cooperation in obtaining your travel document;
- 10. Any available mental health reports.

You may submit any documentation you wish to be reviewed in support of your release, prior to the date listed above, to the attention of the Officer and address below. English translations must be provided pursuant to 8 CFR 103.2(b)(3). An attorney or other person may submit materials on your behalf. The deciding official will notify you of the decision in your case. Attached to this notice is a list of free or low cost legal representatives who may be able to provide assistance to you in preparing your case.
