JOINT MOTION TO VACATE

1 The parties, through their respective counsel of record, respectfully request an
2 order vacating the current briefing schedule. On July 14, 2025, Petitioner filed a petition
3 for writ of habeas corpus. ECF No. 1. On July 15, 2025, the Court issued an order
4 requiring Respondent's response to be filed on or before July 28, 2025, and Petitioner's
5 traverse to be filed on or before August 4, 2025. ECF No. 3.

6 Petitioner is currently scheduled to appear before an immigration judge on
7 August 5, 2025, for a master calendar hearing relating to his removal proceedings.

8 The outcome of the master calendar hearing may potentially change the scope of
9 briefing and/or issues to be raised in the briefing. As such, the parties request that
10 briefing schedule be vacated. If the habeas petition is not dismissed by August 12, 2025,
11 the parties will file a joint status report.
