**JOINT STATUS REPORT**

1 Pursuant to the Court's July 25, 2025 Order (ECF No. 8), the parties, through  
2 their respective counsel of record, providing the following status report. On August 5,  
3 2025, Petitioner appeared before an immigration judge for a master calendar hearing  
4 relating to his removal proceedings, wherein Petitioner requested to be released from  
5 detention on bond. That same day, on August 5, Petitioner filed a motion for bond, and  
6 the immigration judge set a bond hearing for August 14, 2025. The immigration judge  
7 also set a master calendar hearing for September 3, 2025, relating to Petitioner's  
8 removal proceedings.

9 The outcome of the bond hearing may potentially change the scope of habeas  
10 briefing and/or issues to be raised in the briefing. As such, the parties request that the  
11 Court set a briefing schedule with Respondents' response to the habeas petition due no  
12 later than August 28, 2025, and Petitioner's optional traverse in support of the petition  
13 due no later than September 4, 2025.
