Please take notice that Petitioner Olban Enedin Mancía Castro hereby withdraws his

1. Petitioner filed the motion on July 16, 2025. [Docket No. 1.]

2. On July 30, 2025, Petitioner appeared before Immigration Judge Ralph E. Girvin in a custody redetermination hearing pursuant to 8 C.F.R. § 1236.
3. On July 31, 2025, IJ Girvin ordered Petitioner be released from custody of the Office of Immigration and Customs Enforcement on bond.
4. On August 1, 2025, Petitioner was released from custody of the Office of Immigration and Customs Enforcement on bond.
5. Because of Petitioner's release on bond, Petitioner wishes to withdraw his Petition.
6. Petitioner maintains that he was held in violation of his Fourth and Fifth Amendment rights.
7. Petitioner hereby withdraws the Petition without prejudice
