JOINT STATUS REPORT

1 Pursuant to the Court's September 17 Order (ECF No. 11), the parties, through
2 their respective counsel of record, provide the following status report. At the time of
3 this status report, Petitioner remains in ICE custody at the Otay Mesa Detention Center
4 in San Diego, California. On August 27, 2025, Petitioner appeared before an
5 immigration judge for a master calendar hearing in his 240 removal proceedings at the
6 Otay Mesa Immigration Court. The immigration judge scheduled a deadline of October
7 24, 2025, for the parties to file additional evidence and briefs relating to Petitioner's
8 applications for relief from removal. The immigration judge set Petitioner's
9 individualized merits hearing for November 21, 2025. The September 15 hearing
10 referenced in Petitioner's reply was set in his prior 240 removal proceedings, at the San
11 Diego Immigration Court, that were dismissed. No hearings have occurred in
12 Petitioner's current 240 removal proceedings since August 27, 2025.
