2 Plaintiffs, by and through undersigned Counsel, files this Reply to Defendant's
3 Response to Motion for Temporary Restraining Order. Plaintiffs are filing this with the
4 knowledge that this motion was filed in the incorrect case, and intend to re-file this reply
5 in 3:25-cv-5800-TL if/when Defendants re-file their response. However, because
6 Defendants' Response is docketed already in the above captioned action, and due to the
7 emergency nature of this motion, Plaintiffs feel compelled to docket this Reply now to
8 provide the Court with their reply as quickly as possible to enable the Court to make a swift
9 ruling.

10 Defendant has again failed to provide a qualified interpreter. Plaintiff has
11 specifically requested a Tamazight interpreter from the Haouz region of Morocco. *See*
12 Exhibit 1. Plaintiff is only proficient in that specific dialect. Nonetheless, Defendant claims
13 to have secured a qualified interpreter. However, the interpreter provided speaks the
14 Aulouz dialect, which Plaintiff does not understand—a fact well known to the Court. In
15 light of the foregoing, the Court should enjoin the individual hearing scheduled for today.
