VOLUNTARY DISMISSAL WITHOUT PREJUDICE**

COMES NOW the Petitioner/Plaintiff, Ahmad Mohammad Faleh Alalawneh, by and through undersigned counsel and hereby files the instant Notice of Voluntary Dismissal Without Prejudice pursuant to Fed. R. Civ. P. 41 and states as follows:

1. On or about August 11, 2025, an Immigration Judge at the EOIR Miami Krome Immigration Court conducted a custody redetermination hearing pursuant to 8 C.F.R. § 1236 and entered an order *inter alia* granting the

Petitioner/Plaintiff release from the Respondents/Defendants' custody under bond of \$5,000.00.

2. Counsel for the DHS and the Petitioner/Plaintiff waived appeal of the custody redetermination.

3. Accordingly, the instant action is moot.

4. Pursuant to Fed. R. Civ. P. 41(a)(1), the Petitioner/Plaintiff may voluntarily dismiss an action without this Honorable Court's leave prior to the Respondents/Defendants' filing of an answer or motion for summary judgment.
