**PETITIONER’S REPLY TO OPPOSITION TO
MOTION FOR FEES AND COSTS UNDER THE
EQUAL JUSTICE TO ACCESS ACT**

17 Federal respondents oppose the grant of EAJA fees because they argue the government’s position was
18 substantially justified. The respondents have the burden to show that the government’s position was substantially
19 justified. *See Ibrahim v. U.S. Dep’t of Homeland Sec.*, 912 F. 3d 1147, 1167 (9th Cir. 2019) (establishing that the
20 burden is on the government to show that its litigation position was substantially justified on the law and the facts.”)

21
22 The government has not met its burden to show its position is substantially justified. First, the government
23 argues that the absence of controlling appellate authority foreclosing its new interpretation is dispositive. But the
24 reason there was no prior authority is because its interpretation is completely new and reverses three decades of
25 established interpretation, practice and procedure based solely on current political objectives. It has never been
26 challenged before because the government itself never made this argument before.

1 Second, the new interpretation was not substantially justified because it was not published or made
2 available to either the public or to stakeholders and it was no open for public comment. It was issued in secret and
3 then leaked to the American Immigration Lawyer's Association.

4 In addition, it cannot be substantially justified where multiple courts in now hundreds of decisions along
5 with this court have found that the government's position is in fact, contrary to law. See Attached Addendum listing
6 just the cases in the Ninth Circuit. The addendum lists 429 cases finding that the government's position was
7 unlawful and only 11 decisions that were decided for the government.

8 Finally, the government position is not justified solely because of the subsequent issuance of the decision
9 by the Board of Immigration Appeals, *Matter of Yajure Hurtado*, 29 I. & N. Dec. 216 (BIA 2025) because that
10 decision essentially reiterated the unlawful interpretation that DOJ colluded in in the July 18, 2025 secret memo.
11 Based on the memo being issued jointly by DHS and DOJ, it was clear prior to the issuance of this decision that the
12 BIA would find a way to support the unlawful interpretations.

13 Finally, these cases were taken entirely pro bono because the petitioners were detained and had no access to
14 funds or attorneys other than through pro bono representation and would not have been able to challenge their
15 unlawful detention had it not been for a willingness to provide pro bono representation.

16 In conclusion, if its new position was made in secret, reverses decades of its own interpretation, practice
17 and procedure and almost all courts to consider the issue have found that its interpretation is contrary to law, it
18 cannot be argued that its position is substantially justified.
