Hello Daniel Lopez DeJesus,

Thank you for your letter, and the appended materials describing your pardon for four Oregon criminal court cases. I understand you to be asking to seal the court records for these cases. When I look up your name in the Oregon court database, I do not see any criminal cases. **This tells me that the records of these cases have already been expunged.**

To be clear: the Oregon expungement process is a state process. That means that while the record of the cases may be sealed under Oregon law, a federal background check may still show a record of those cases. However, this federal background check should also reflect that the cases have been pardoned and sealed. There is no process that I am aware of that will remove the record of any Oregon criminal cases from this federal background check.

Here are the cases that are described in your paperwork that are sealed:



I understand you have contacted the Marion County Public Defender's office regarding this question as well. A staff attorney from that office, Christopher Symeonides, informed me that you had contacted their office as well. We agree about the description of your criminal record, so I hope you will consider this letter a response from him as well. The Public Defender of Marion County will not contact you independent of this letter.

I realize you are in a difficult position, and I am sorry our Record Relief Program cannot be of more assistance to you at this time.
