JOINT STATUS REPORT AND STIPULATION OF DISMISSAL

COME NOW, Petitioner, Alma Bella Bowman, and Respondent, Warden, Stewart Detention Center, (collectively the “Parties”) and file this Joint Status Report in accordance with this Court’s order dated September 11, 2025 (Doc. 10), showing the Court as follows:

1. On August 1, 2025, Petitioner commenced this action seeking a Writ of Habeas Corpus. Doc. 1.
2. On August 7, 2025, Petitioner submitted Form N-600, Application for Certificate of Citizenship with U.S. Citizenship and Immigration Services (“USCIS”).
3. On September 2, 2025, the Parties submitted a Joint Motion to Stay proceedings in this case in light of Petitioner’s submission of her N-600 application. Doc. 9. Respondent agreed not to transfer or effectuate Petitioner’s removal for 90 days from the date of the motion’s submission. *Id.*
4. On September 11, 2025, this Court entered an order staying proceedings through December 1, 2025. Doc. 10.
5. On November 24, 2025, Petitioner was released from the Stewart Detention Center

on an Order of Supervision.

6. To date, Petitioner's N-600 application remains pending with USCIS.

7. In light of Petitioner's release from the Stewart Detention Center, pursuant to Federal Rule of Civil Procedure 41(a)(1)(A)(ii), the Parties hereby stipulate and agree that this action be dismissed without prejudice. *See* Fed. R. Civ. P. 41(a)(1)(B). The Parties agree to bear their own costs, including any possible attorney's fees or other expenses of litigation. *See* Fed. R. Civ. P. 41(a)(1)(A)(ii).
