RESPONDENTS' STATUS REPORT

Respondents, through the undersigned Assistant United States Attorney, file this Status Report in compliance with the Court's October 29, 2025, Order (Dkt. No. 17) to inform the Court as follows:

1. On August 25, 2025, the Court found that Respondents had not conducted the 180-day Post Order Custody Review ("POCR") and ordered Respondents to conduct the 180-day POCR within 60 days or remove Petitioner. The Court further ordered Respondents to file a status report by October 24, 2025 (Dkt. No. 12).
2. Respondents filed a Status Report on October 24, 2025 (Dkt. No. 14).
3. After the filing of the aforementioned Status Report, this Court issued the October 29, 2025, Order (Dkt. No. 17). The Court granted Petitioner's habeas petition, finding that Respondents failed to follow their own regulations and this Court's Order because the 180-day POCR was not completed.
4. Respondents file the instant Status Report to confirm that Petitioner was released from custody on Monday, November 3, 2025, in compliance with the Court's October 29, 2025, Order

(Dkt. No. 17). The undersigned awaits official documentation relating to Petitioner's release, which will be provided to the Court once received.

5. Although the Court has granted Petitioner's habeas petition, Respondents also respectfully clarify that the 180-day custody review had been completed on August 13, 2025, prior to the Court's August 25, 2025, Order. *See* Dkt. No. 15, Administrative File 3, at Bates 258; Dkt. No. 14-1, ¶ 16.

WHEREFORE Respondents respectfully file the instant the Status Report in compliance with the Court's October 29, 2025, Order confirming Petitioner's release. The undersigned will submit official documentation to the Court regarding Petitioner's release once received.
