Petitioner hereby notifies the Court of supplemental authority issued on August 25, 2025, after the Court heard argument on Petitioner's application for preliminary injunction on August 22, 2025. Petitioner submits Orellana v. Baker, No. 1:24-cy-01788-TDC (D. Md.). There, the court granted a petition for writ of habeas corpus for a noncitizen who was re-detained after previously having been released in 2023. The court held that immigration officials failed to comply with the detention revocation regulations at 8 C.F.R. § 241.13 and that the failure to follow the regulations was a violation of due process. *Id.* at 15.
