Petitioners, S-M-J and J-M-L, through counsel, file the attached supplemental authority in support of Petitioners' request that this Court expeditiously issue an Order directing Respondents to release Petitioners from custody forthwith and barring future arrest or detention by Respondents, absent leave of this Court.

The first attached supplemental authority is U.S. District Court Judge Kimberly K. Evanson's August 19, 2025, Order Granting Petition for Writ of Habeas Corpus in *E.A. T.-B. v. Cammilla Wamsley, et al.*, Case No. C25-1192-KKE (USDC WDWA Aug. 19, 2025). Judge Evanson ruled from the bench during the hearing on August 18, 2025, ordering immediate release, and issued the attached Order. The conclusion of the attached Order provides:

For these reasons, the Court GRANTS the habeas petition (Dkt. No. 4), DENIES Respondents' motion to dismiss (Dkt. No. 17), and DENIES Petitioner's motion for injunctive relief (Dkt. No. 24) as moot. The Court ORDERS that Petitioner shall be released from custody immediately and may not be re-detained until after an immigration court hearing is held (with adequate notice) to determine whether detention is appropriate.

The second attached supplemental authority is U.S. District Court Judge Aiken's August 21, 2025, Opinion and Order in *M.S.L. v. Bostock, et al.*, Case No. 6:25-cv-01204-AA (USDC Dist. of Oregon Aug. 21, 2025). Judge Aiken's Order is directly on point in its analysis regarding S-M-J in this case. S-M-J is J-M-L's son.
