_ On July/14/2020 I asked for my deportation because im Palestinian. there is no deportation to Palestinians because Palestine is not a state. That was a win for me, thats why I waved all my rights back then not knowing anything about asylum and all other options. I tried to reopen my case this time but they deny my motion.

_ Your honor, the situation between Palestinians and Israel is no secret. So do you really think its righteous to be deported to that place were Palestinians facing all they facing. I need TPS, please push the issue if you cannot grant my habeas. ICE denying every request I ask for.

_ In the letters I got, I see that you granted the consolidation of all the motions and I wanna thank you, I not knowingly send it every address I get a hold of trying to get out of this place. I really need help.

_ I also seen that ICE got there motion granted to September/12/2025. They claim my passport application from Israel is pending. Meanwhile they talking about the door to deport me to a third country is still open.

_ We have access to the news in this facility through the tablets, ICE claim im going to be free where ever I be deported to. Nope, thats a lie. Every inmate that facing deportation to a third country red that article talking about the 7 guys were deported to Africa.

_ After they went to Africa they remain in jail to this date. Three were deported from Sudan to there countries after the united nation helped them and got there travel documents from there mother countries.

_ The other four still remain in Sudan's custody, very bad conditions. They treat them so bad like animals. El silvadore jail also the same.

_ I have no country that I could f=go to if I get deported to Africa or anywhere else. The united nations wont be able to help me period. Im going have to stay in jail god knows for how long. most for life since Palestine will never be a state.

_ ICE also mention my narcotics position charge, I got sentenced 4 years out my suspended tim for less than half a gram of ice. It was way less than half a gram. Its just Mississippi.

_ 100\$ theft charge was completely hunger. I just moved from Memphis to Dallas and I had no money nor food for a week. I asked for help at the gas station and on the street but no one gave me a penny. I was dying. I went inside Walmart and ate 25\$ worth of food. Then after the security stop me, I felt a sleep right away waiting on the police to come get me.

_ Your honor, im not a criminal. I just go through things like anybody else. Im trying to live.

_ Your honor im not a flight risk nor a danger to community.

_ Your honor I fear for my life to be deported to Israel.

_ Your honor I fear for my life to be deported to any third country.

_ Your honor help me please, all im asking is to live free.

_ Its my right if I don't get my habeas granted to get TPS, at least till war is over.
