I, Pirzada Ahmad, hereby declare and state the following:

- 1. My name is Pirzada Ahmad. I am currently employed as an attorney with the law firm of Dontzin Kolbe & Fleissig LLP. I am pro bono counsel of record for Petitioner M.T.M. in this action. Local co-counsel filed a pro hac vice application for me on August 28, 2025.
- 2. In order to aid the Court, I would like to provide a rough chronology of events as I understand them.
- 3. At 6:47 PM PT yesterday, I spoke on the phone with M.T.M. with the aid of his immigration counsel, Madhavi Narayanan, and an interpreter that Ms. Narayanan provided. M.T.M. shared his experiences with me:
 - a. Early morning, August 28, 2025: M.T.M. was at Golden State Annex Facility, where he has been detained continuously for a long time.
 - b. Approximately 3:00 AM PT, August 28, 2025: M.T.M. was put on a bus and transported to another facility, arriving at around 4:15 AM PT.
 - i. Based on information provided directly to me by the U.S Attorney's Office for the Eastern District of California, it appears that facility was in Bakersfield, California.
 - c. Approximately 11:00 AM PT, August 28, 2025; M.T.M. was put on a bus and transported to an airport in Victorville, California. The bus ride took approximately four hours.
 - d. Approximately 3:00 PM PT, August 28, 2025: M.T.M. arrived at the airport in Victorville, California. By this point, M.T.M. had repeatedly requested the opportunity to speak to counsel but was ignored each time.
 - e. Sometime between 3:30 PM PT and 4:00 PM PT, August 28, 2025: M.T.M. was put on a plane and strapped down in a very rough and uncomfortable manner. The plane took off shortly thereafter, and the flight lasted approximately 45 minutes. The rough and uncomfortable nature of how ICE handled M.T.M. caused him significant pain and he vomited several times during the flight. M.T.M. promptly requested medical attention. It is unclear if he was provided

medical attention.

- f. Approximately 5:00 PM PT, August 28, 2025: The flight lands in what appeared to be somewhere in southern California. M.T.M. was not sure where he precisely was, but he believed he was in southern California based on what he saw and heard.
- Approximately 5:00 PM PT to 7:45 PM PT, August 28, 2025: M.T.M. repeatedly asked ICE to speak directly to his counsel because there was a language barrier between M.T.M. and the ICE officials. During my call with M.T.M. at 6:47 PM PT, I asked him to hand the phone to an ICE official and tell them his lawyer wanted to share important information about a court order (this Court's Order, ECF Dkt. 6). The ICE official promptly hung up the phone. M.T.M. managed to call us again immediately, but the ICE official again promptly hung up the phone. After this, we were unable to speak with M.T.M. further that evening.
- 4. At approximately 1:30 AM PT on August 29, 2025, M.T.M. called Ms. Narayanan and informed her that after our call with M.T.M. last night, ICE put him on another flight, this time to somewhere in Louisiana, where he was then moved to Alexandria Staging Detention Facility. Upon information and belief, it is my understanding that ICE often transports immigrant detainees to Alexandria Staging Detention Facility in order to promptly effectuate a removal. As far as I know, M.T.M. is still at Alexandria Staging Detention Facility.
- 5. I would now like to share details about Petitioner's efforts to file and notice this action and the information provided to Petitioner's counsel by the United States Attorney's Office for the Eastern District of California:
 - a. 12:58 PM PT, August 28, 2025: I provided notice of this action and full and complete copies of M.T.M.'s habeas petition, motion for temporary restraining order, exhibits, and proposed order to the United States Attorney's Office for the Eastern District of California via email to Edward.Olsen@usdoj.gov (Edward Olsen, Chief of Civil Division), Elliot.Wong@usdoj.gov (Elliott

Wong), and Michelle.Rodriguez@usdoj.gov (Michelle Rodriguez). In that email, I explained that we tried to find out M.T.M.'s whereabouts by repeatedly calling several ICE office phone lines on August 27, 2025 and August 28, 2025, but none of the ICE officials we spoke to knew exactly, although one official said M.T.M. seemed to have been put on a flight to Ghana on August 27, 2025. I also explained that M.T.M. had repeatedly asked to speak to counsel but was ignored each time.

- b. Still around 12:58 PM PT, August 28, 2025: At the same time as I emailed the United States Attorney's Office for the Eastern District of California, Petitioner's counsel Sean Lai McMahon repeatedly attempted to e-file M.T.M.'s habeas petition and motion for temporary restraining order but could not because of a nationwide technical issue with the e-filing portal that an Eastern District of California helpdesk clerk informed us of thereafter. Mr. McMahon tried to file in several ways and asked the helpdesk for assistance by phone and email. Mr. McMahon asked the clerk whether any alternative method of filing would be accepted by the court due to the emergency nature of our filing, and was initially pointed only to Local Rule 134(c) indicating that filings would be considered timely in the event of a technical outage.
- c. 3:11 PM PT, August 28, 2025: At the direction of a clerk in the Eastern District of California, M.T.M. was able to get on file via counsel's 3:11 PM PT email of M.T.M.'s submissions to the emergency filing email address. M.T.M. and his counsel express their gratitude to each of the clerks that assisted us yesterday.
- d. 3:45 PM PT, August 28, 2025: Edward Olsen, Chief of Civil Division for the United States Attorney's Office for the Eastern District of California, confirmed receipt of my 12:58 PM PT email and said he forwarded my email and attachments to ICE's Office of the Principal Legal Advisor (OPLA). He also said: "Someone at OPLA is figuring out where your client is now, and I'll get back to you when I hear back."

- e. 4:36 PM PT, August 28, 2025: Mr. Olsen followed up and wrote: "Here's the info I gathered from OPLA: the petitioner departed Bakersfield, CA this morning and arrived at Victorville, CA (Central District) at approximately noon. He was then manifested for a flight to Louisiana and departed Victorville around 2:15pm PST." There are obviously discrepancies between M.T.M.'s experiences and this information provided by Mr. Olsen via OPLA. I do not assume any wrongdoing, but nevertheless, it appears clear that M.T.M. was not put on a flight to Louisiana at 2:15 PM PT.
- f. 4:48 PM PT, August 28, 2025: The Court issues its Order "that defendants shall not remove petitioner from the United States nor transfer petitioner out of this District."
- g. 5:03 PM PT, August 28, 2025: Mr. McMahon provides a copy of the Order to Mr. Olsen and another individual at the United States Attorney's Office for the Eastern District of California (Cheri Buxbaum).
- h. 5:24 PM PT, August 28, 2025: Mr. Olsen confirms receipt and that ICE OPLA is in possession of the Order: "I have passed along the minute order to ICE OPLA to make sure they are aware of the order not to remove your client." Nevertheless, ICE thereafter transferred M.T.M. from (apparently) California to Louisiana.
