Respondent John Mattos, through counsel, submits this Joinder to Federal Respondents' Motion to Dismiss Petitioner's Writ of Habeas Corpus (ECF No. 1) Based on Mootness. (Dkt. 8.)

As Warden of the Nevada Southern Detention Center ("NSDC"), a private facility owned and operated by CoreCivic, Inc. pursuant to a detention services agreement with U.S. Immigration and Customs Enforcement ("ICE"), Warden Mattos had (and has) no involvement in Petitioner's immigration proceedings and no independent authority to release Petitioner.
