I am an Armenian Christian. I entered into this country legally with my parents from Iran in 1985 whom fled after the Shaw Regime change in 79' Revaluation to find refuge. At age 16, I was introduced to drugs and my life wat into a very dark path. In 2005, I was ordered to be removed, however, Iran and the United States of America have no diplomatic relationship, and Iran has no birth certificate or any records that i am from Iran. So for that reason, i was ordered deported on paper, but given permission to live in the United States legally under an immigration law that ONLY applies to those who cannot be removed. "Order Of Supervision"....

My entire family is a American citizen. I, unfortunately is not. However, I am an American! I've lived in Burbank California my entire life. United States is my domicile, however, the Government seems to disagree. My entire life i have faced trouble with my addiction. Incarceration on top of incarceration without any rehabilitation. ICE always in the way, and at the end of my commitment, i get released back into society with the same addiction that got me into trouble from the start.

I was molested when i was 19 yrs of age by an instructor named Mr. Minor. I complaint with the manager and he did nothing. That was my first offense. Courts sent me to Anger Management classes, and that was the results. After that, my addiction became what fueled me to commit crimes. I was parentless and did not know what was wrong with me. I tried to get addiction became what i couldn't because i did not have a high school diploma. So back to drugs, then came my second offense, into the Military, but i couldn't because i did not have a high school diploma. So back to drugs, then came my second offense. - 1) I was molested when I was 19 years old by Mr. Minor. In 2017, i was in county jail of Los Angeles, Mr. Minor ended up being my instructor, and he remembered me. I told him that "he had violated me back in anger management classes". He said "he knew that, and he was sorry, and that I was still handsome". Before leaving to prison for another sentence that i was given, I filed a complaint against Mr. Minor to Sgt. Lee. I did it right before I left so there would be no retaliation.
- 2) In 2006, i was beaten by Burbank police department and i filed a complaint against them. Even with the Internal Affairs. Courts did not believe me and i was sentenced again. Come to find out when i was released, that the entire Burbank Police department was under investigation for the same complaints that i filed that the courts believed i was not telling the truth. The Feds took over Burbank. Even the Internal Affairs. Later, a lot of arrests took place including the Major's right hand man who was arrested for selling guns to a Gang that i did not want to speak to with the police, which led a killing of a rookie police officer in front of a Ramada Inn Hotel. That is why i was raided by Burbank Police Department after my release due for revenge for not telling. The officer that arrested me, his name was Officer Gunner. He was the one officer that killed himself when the Feds were investigating. We filed a motion with the courts prior my sentence against those 22 officers. 21 of those officers were granted by the courts. My attorney at that point was Khoury Naser. This all can be verified through news paper article and other cutlets.
- 3) During this timing situation, I was harassed by Burbank PD. I was arrested again for a false charge. Assault to a peace

officer. These were going on until I can be put away to cover the first arrest. I filed a complaint against both officer's after I waited 3 days to be booked. I had many marks on my face, that had to heal. Once filed, there happened to be a witness that had called the Burbank PD, complaining what she/he had saw by those 2 officer's. That case never made it to the court room. The 2 officers were fired, or placed on leave. The watch Commander ended up resigning. These 2 paragraphs go in hand to hand.

- 4) In my Apartment where i had a lease. # gang members walked in a robbed me. Before the robbing, I was beaten with their pistol, left me on the floor puddle of blood. Neighbors called the police. When police arrived, finger print was taken and file number was left. Home Invasion. I have proof of that police report as well.
- 5) Now in Federal prison. Still with the same addiction.....i was beaten of the yard do to an officer exposing something personal from my record that prison should not expose ever. Just for the fact that i was pushing papers on him for stealing over a 1000 worth of stamps. (That's currency). Sitting in the SHU with a broken nose, that still not has attention till today, my fiance and I filed with the DOJ, Central office in Washington, Western Region etc....I have full evidence of that to. I wrote letters to my fiance explaining what had happened and with all the names of officers who were involved, and the mail room was cutting out all the names and mailing the letter home with nothing but cut outs. We filed that and we have copies to support. Last time I checked, that's mail tampering. Its a Federal crime.
- 6) After my new destination in federal prison, I was forced to live with a crazy drug addict. Did not know what type of drug he was on, but it wasn't normal. I tried to move so many time due to my medical chrono, but it failed. However, the real reason was that he was using something i never heard of and he tried to rape me 3 times. I never slept in that cell when he was awake, and i feared for my life and for my safety all the time. i remained with a lock in my hand in case he tried again. 3 fights over 3 attempts did not work...Until I decided to file on him. I filed with PREA, DOJ and a 3rd party. He was finally transferred. During waiting for transfer, he was left in the SHU (Segregated Housing Unit), he sent notes and carved my name on walls in the SHU, tray lids and stated that SIS told him who filed the report. Now i live here worried.

I filed compassionate release and explained all these things. I even requested to be sealed from public access. that did not work. now everything is out in the open and i live here everyday terrified. I contacted the Public Defenders office regarding this matter and they are looking into helping me seal those claims for my safety.

My voice is never heard regardless how loud i scream. I need my life back!!!!! I cannot go back. I shouldn't go back. I want to be buried next to my mother who died during Covid, and later, next to my father when his time comes. Not in some Islamic nation that I know nothing about, nor speak the language, and where i have NO ONE. That is cruel. Looking at what is happening today....there is no way that I am the target of removal. If today was what was 25 yrs ago...i would have never been faced what I have faced and lost my residency statues. I need help. I believe U-VISA is a way to go. I have filed for Asylum, Suspension of Deportation, I-246, I-212, I-601, I-489, and many other applications, yet not heard back and don't even know if they received it. My released date is approaching, and without my immigration issue, i would of been home 30 months ago. I am being forced to do my entire time for a civil matter, when i am eligible for early release. Same thing continues to happen. State Prison, and now Federal Prison. Immigration always blocks me from early home or halfway house. Be able to have a place to live, and to be able to find a job before i am free. Instead, I get released straight to society, with no help leaving me with my addiction, and back to the revolving cycle. Mass incarceration. I am not a monster.....I am just a addict that had self destructed, lost his entire youth, young adult life between these walls that is yearning for help.... l even signed up for the Military Draft during this time in Federal Prison. In case United States needs me to help and preserve this great Nation.

The attorney that represented me on my immigration case back in 2005. Well, he was fired shortly after that and there is no whereabouts of him. Makes me wonder if he even was an immigration attorney. His name was Dean Sellers from Los Angeles. I guess he was working for a firm under their license without even have a bar license himself. To be fare and honest. I don't have money like that to spend, I just need help restoring my life. I want to file lawsuits against what i have gone through just with the BOP, but i am afraid because everything i public access and i don't know how to seal it going forward. So i stay quite. Just like I always have in the past. I feel like I have no rights and no voice. This was just a brief of everything that had happened to me. I hope you can help me.

ICE Office Agency/Department of Homeland Security/Executive Immigration Customs and Enforcement

My name is Arno Abramian. I am currently in custody at FCI Victorville CA. I have been trying to get in contact with your department regarding an ICE detainer that was placed on me. My situation is different. I know I have a Final Order of Removal. but due to the fact that my country of origin and the United States has no diplomatic relationship, I was released back into the U.S. under 'Order Of Supervision'. This detainer is causing harm while I am in custody. Its depriving me from participating in programs such as RDAP (Residential Treatment), and earn FSA credits to shorten my sentence. These are crucial essentials that can help a person to work their way out to society and stay out. My entire life of addiction, I never get the opportunity to do this while incarcerated. My addiction has depleted me entire young adult life. I understand that I made many mistakes, but I'm asking to please not turn the page on me, and lets in fact try to go back to page one. Do something different. I have been trying to get a hold of your agency, spoken with the BOP facility to get a hold of your agency to ask for your office to set up an interview with me so we can talk about my situation. I have been helpless, with no progress. In the past, my detainer gets removed at the end of my sentence. By signing papers, which are the 'Order of Supervision' releases conditions and making sure my contact information is current. Meanwhile for that day to approach, I waste years in prison yet again not being able to engage in programs. My time is sensitive. I must have certain amount of time left on my commitment to be able to enroll and engage. This detainer is NOT allowing the BOP to let me engage. I am asking for your office to please look into my file now and better understand my situation. My deportation was in 2005, and I was not deported due to countries conditions. Ice office has my phone number on file since 2005, and it is still current. In-fact, I spoke with an ICE agent in June 2020 and I was told by the Los Angeles Office that "due to covid, not report". A report was conducted based on the phone call. Please have your Field Office make an appointment to speak to me as soon as possible, or take a better look on my file now rather then later for a conclusion. Thank you

Federal Bureau of Prisons (FBOP)

I have a ICE detainer that is depriving me from participating in RDAP, and FSA credits. I have an "Final order of removal" from the U.S. in the year 2005. Due to being no relationship between the U.S. and Iran, I am a non-deportable. I was released back into the U.S. with release conditions under "ORDER OF SUPERVISION". I don't have any courts, any Judges to see, just a officer from ICE to have me sign some papers prior to my release. The same papers that I am trying to sign now rather then later, the same papers that I submitted to BOP for proof. I have been in BOP from 5/29/2020, and i have not had a ICE detainer. In-fact ICE knew I was in custody because they called my phone number that I have on file with them for the past 2 decades. Ever since I have been here at the FCI Victorville, I had a detainer placed on me. This is causing major issues regarding earning RDAP and FSA while serving my commitment. I have been trying to resolve this issue since 3/03/22 and been going in circles. I have submitted all types of papers, such as proof of military draft, order of supervision release conditions, and a letter explaining my story, that way BOP can understand my situation and realize that I will be released back into the U.S. and that I should be eligible for RDAP and FSA credits. It is unfair and unjust that I must just sit here in prison, not being able to earn credits off towards my sentence, enroll into RDAP, and shave off at least 25 months of my sentence to get home sooner. Instead sit here in prison and at the end of my commitment, ICE is contacted for pick up, and at that time, ICE evaluates my case more thoroughly and removes the detainer. This happens every time I am in prison, the only difference this time is that State Prisons (CDC) ONLY depriving me from Residential Releases/Halfway House vs Federal Prison (BOP) deprives me entirely. I am only trying to help BOP to better understand me and help me by allowing me to participate in these programs and earn my credits towards home. All I want is to BOP to contact ICE, realize that I am not a deportable inmate with a letterhead from ICE, that way BOP can make me eligible for RDAP and FSA. I have been going in circles at the BOP level and I feel like the BOP does not care to try to rehabilitate me at all, only quick to deprive me. My case is different and I believe that the criteria should be different as well. I cant get direct contact through the BOP so I can contact ICE myself to have this resolved now, rather then later. Later is to late. Later is my actual outdate. The results are going to be the same. HOLD WILL BE LIFTED!!! I feel helpless, alone and another forgotten person in the BOP system. Thank you
