JOINT STATUS UPDATE

The parties submit this joint status update in accordance with the Court's October 1, 2025, Order, ECF No. 14.

Respondents provided Petitioner with a bond redetermination hearing under 8 U.S.C. § 1226(a) on Tuesday, October 7, 2025, after which the Immigration Judge denied Petitioner's request for release on bond. A true and correct copy of the order denying bond is attached as Exhibit 1 to this filing. The IJ held another hearing on Friday, October 10, 2025, related to Petitioner's mental competency. *See Matter of M-A-M*, 25 I. & N. Dec. 474 (BIA 2011). The immigration court continued the matter at Petitioner's request. The immigration court also granted Petitioner's motion for a subpoena to secure his medical records. The parties agree regarding the effect of these developments on this matter.

The Court can now enter judgment for Petitioner consistent with its October 1, 2025, Order and dismiss Petitioner's remaining requests for relief. Petitioner has received the bond hearing he requested, and the Court's October 1, 2025, declaration that Petitioner is subject to detention under § 1226(a)(1), not § 1225(b)(2), continues to apply throughout his current custody until that declaration is amended, vacated, or overturned. Petitioner's

asserted injury has therefore been remedied, and no issues remain for the Court's resolution.
