RESPONDENTS' STATUS REPORT

Respondents submit the following Status Report pursuant to the Court's Order granting, in part, Petitioner Manuel Moya Pineda's Petition. ECF No. 21 at 4.

In his Petition, Petitioner sought habeas relief in the form of immediate release or a bond hearing. *See generally* ECF No. 1.

After briefing, the Court granted, in part, the Petition. *See* ECF No. 21.

Specifically, the Court ordered Respondents to provide Petitioner with a bond hearing within seven days of the Order (on or before October 27, 2025). *Id.* at 4. The Court also

directed Respondents to include, in a status report, a copy of the warrant justifying Petitioner's arrest and detention. *Id.*

Pursuant to that order, Respondents provide the following status update. On October 23, 2025, Petitioner appeared for a bond hearing before an immigration judge. Petitioner was granted bond. See Exhibit 2 (Bond Order). Petitioner posted bond, and on October 27, 2025, he was released from custody. A copy of the warrant (I-200) justifying Petitioner's arrest and detention is attached as Exhibit 2.
