**JOINT STIPULATION FOR  
RELEASE OF PETITIONER  
AND FOR DISMISSAL OF  
HABEAS PETITION  
WITHOUT PREJUDICE**

Petitioner and Federal Respondents agree and jointly stipulate to the issuance of the attached proposed order dismissing this habeas petition without prejudice and remanding the matter to the United States Immigration and Customs Enforcement (ICE) for the immediate release of Petitioner Mehran Makari Saheli on an order of supervision with conditions pursuant to ICE's regulations, 8 C.F.R. § 241.5.
