**STIPULATED NOTICE OF  
VOLUNTARY DISMISSAL**

Petitioner Jose Lopez Reyes and Respondents hereby stipulate that this action be dismissed without prejudice as to all claims, causes of action, and parties, with each party bearing their own attorney's fees and costs, pursuant to Federal Rule of Civil Procedure 41(a)(1)(A)(ii). Mr. Lopez Reyes filed the instant habeas petition with a motion to expedite and request for an order to show cause on September 26, 2025. The Court issued its Report and Recommendation that the habeas petition be granted and that that Petitioner be ordered released, on October 15, 2025, and provided the parties a briefing schedule for objections. However, Petitioner was ordered removed on October 14, 2025, at a hearing where he appeared pro se and

1 waived appeal. Accordingly, he has now agreed to dismiss the instant habeas petition. The  
2 dismissal shall be effective upon filing of this joint stipulation.
