On October 29, 2025, the immigration court held a bond hearing for Petitioner. He was granted a \$7,500 bond, and Petitioner posted that bond. Nevertheless, Plaintiff, through counsel, intends to file a Notice to the Court to memorialize Defendants' five-day delay in processing Plaintiff's bond payment after the immigration judge granted bond.
