**JOINT STATUS REPORT**

In accordance with the Court's November 18, 2025 order, Petitioners Hayam El Gamal, Habiba Soliman, E.S., A.S., H.S. and O.S. and Respondents Kristi Noem, Pamela Bondi, Todd Lyons, Sylvester Ortega, and Jose Rodriguez, Jr. (hereinafter "Parties") file this joint status report apprising the Court of the status of potential resolution.

On November 6, 2025, the Department of Homeland Security ("DHS") obtained a discretionary stay from the Board of Immigration Appeals ("BIA"). *See* Attached BIA Order. Respondents do not plan to release the family on December 2, 2025, when the automatic stay is dissolved. As a result, Petitioners will move for leave to amend the habeas petition to incorporate a claim (or claims) challenging Petitioners' ongoing detention under the discretionary stay.
