463 HABEAS Corpus

- 1) I, Dmitrii BELONOGOV [REDACTED] currently detained by ICE at FCI Berlin, 1 Success Loop Road, Berlin, NH. 03570.
- 2) I first arrived in United States on 08/24/1993 as a refugee from Russia.
- 3) On 10/16/2001 I was ordered by Immigration Judge to be deported for a period of 10 (ten) years for a crime I have committed in the State of Massachusetts. However, my deportation took place on 03/16/2012 because Russian Government refused to provide me with travel documents.
- 4) On 03/29/2022 I took my family and fled Russia because I was [REDACTED].
- 5) On 05/04/2022 I was paroled back into United States (Exhibit A), and was placed on Supervised Release (where I had to check in with ICE by e-mail).
- 6) On 03/21/2023 I hired an attorney to file I-589 Asylum Application which was filled out on 04/25/2023 and filed with USCIS within 1 (one) year as required by law. (Exhibit B).
- 7) On 05/10/2023 I requested a travel document (passport) in Russian Embassy (in case my asylum application is denied, so I can travel and seek asylum in other country), but was rejected. (Exhibit C)

8) On 04/17/2024 I applied for travel document with USCIS I-131 Re-parole which is still pending (to have some kind of document to travel and seek asylum in another country, because I will be detained and prosecuted if I go back to Russia) (EXHIBIT D).

9) On 06/10/2024 I checked in with ICE. (EXHIBIT E).

10) On 09/27/2024 I e-mailed ICE my new phone number, as required by my supervised release. (EXHIBIT F).

11) On 02/10/2025 I received an e-mail from ICE to appear in person on 02/14/2025.

12) On 02/14/2025 I went to ICE/EOR in Burlington, Massachusetts and was detained and charged with an "Arriving Alien" (EXHIBIT G), knowing that my next check in date is on 06/03/2025 (EXHIBIT H), and I have been checking in since 05/25/2022 while waiting for court. (EXHIBIT I).

13) On 07/25/2025 I had my Individual Hearing and my asylum application was denied. I did not appeal that decision (it is not possible to do it pro-se from this facility).

14) I believe that I was purposely and illegally detained. I believe that an "Arriving Alien" did not applied to me, because I am paroled asylum seeker.

15) I believe my detention is unlawful and unconstitutional because:

1) I have not violated any Immigration order or any criminal law since I been paroled back int United States.

2) I did not vldate my supervised release.

3) It is not possible to secure my deper= tation at this time because Russian Government once again refuse to provide me with travel passport.

16) I believe that since I am not being deported for any Immigration order that is being violated or any crime I should have a chance to take my wife and child and go seek asylum in another country.

17) I am asking this honorable Court to release me under any conditions of Supervise Release so I can re-unite with my family until any deportation is possible.

18) I am not a flight risk or danger to community. I did not violate any conditions of my release. I am productive member of society that held 2 (two) jobs and paid taxes.

In my own behalf I declare under penalty of perjury that the foregoing is true and correct.
