Respondents file this status report as ordered by the Court. See ECF No. 16 at 11. Petitioner was given a bond hearing on November 7, 2025. Bond was granted in the amount of \$1,500. As of early afternoon today, ICE states that Petitioner had not posted bond and remains in detention. A copy of the Immigration Judge's order is attached as Exhibit 1.

Petitioner's counsel stated in an email to undersigned counsel this afternoon that the bond fund that Petitioner is working with initiated payment at 1:49 pm Mountain Time today. However, ICE has not approved the request. Petitioner's bond fund received an email saying that the request to pay was made after hours. Petitioner believes that he will remain in detention likely at least through Wednesday given the federal holiday tomorrow, Tuesday November 11, 2025.
