STATUS REPORT

TO THE HONORABLE DISTRICT JUDGE D. SALDANA:

1. On November 14th, 2025, a Redetermination of Custody Status Hearing was held before Immigration Judge M. Garcia.
2. The petitioner, Mr. Lasha was represented by Attorneys Veronica Cardenas and David H. Square.
3. The Department of Homeland Security was represented as well.
4. The Immigration Judge after hearing arguments from the attorneys set a bond in the amount of \$5,000.00. *See* Exhibit 1- Bond Order
5. The Department of Homeland Security, reserved appeal.
6. The hearing was then adjourned and the parties were excused.
7. As of drafting of the status report, no automatic stay has been invoked by DHS through ECAS filing system for Immigration Court.
8. Petitioner's counsel will advise the Court if DHS invokes the automatic stay.
9. The Petitioner's family tried posting the bond but was not allowed to post. The reason was that cutoff time was reached and DHS reserved an appeal. *See* Exhibit 2- ICE CeBonds System
10. Petitioner's counsel will file another status report on 11/17/'25 to advise the Court on the matter.
